The amendments to Engrossed HB 1009 amend Sections 19-13.1 and 4-01-21 relating to license, inspection, and registration fees, and the agriculture commissioner's salary.

The amendments made the following changes: 1. Section 19-13.1: The first \$727,500 of fees will be deposited in the environment and rangeland protection fund. The funds referenced above were previously deposited in the general fund. 2. Section 4-01-21: the agriculture commissioner's salary was updated to reflect the conference committee recommendation. 3. The conference committee adopted the agreed upon compensation and benefit package. 4. The conference committee added spending authority for speciality crop grant - \$625,000. 5. The conference committee added general fund authority for desktop support, ND Mediation Service, and livestock auction market news reporting - \$113,000.
