- 2 association; to provide space for highway patrol training; and to declare an emergency.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4	SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds
5	as may be necessary, are appropriated out of any moneys in the general fund in the state
6	treasury, not otherwise appropriated, to the state fair association for the purpose of defraying
7	the expenses of the state fair association, for the biennium beginning July 1, 2013, and ending
8	June 30, 2015, as follows:

- 5 SECTION 4. EMERGENCY. The capital assets line item in section 1 of this Act is declared
- 6 to be an emergency measure.
