5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. Section 57-06-17.5 of the North Dakota Century Code is created and enacted as follows:
- 57-06-17.5. New natural gas gathering and collection systems property tax
 exemption.

A natural gas gathering pipeline of a three-inch [7.62-centimeter] diameter or largersmaller, or having a pressure of twenty-five pounds per square inch [1.75 per kilograms per square centimeter] or less, and its associated equipment, or a natural gas or natural gas liquids collection system which is initially placed in service on or between January 1, 2013, and

- 14 <u>December 31, 2017, is exempt from property taxes for the first taxable year after the line is</u>
- 15 <u>initially placed in service, and the taxable valuation as otherwise determined by law on the</u>
- 16 gathering pipeline or collection system and the associated equipment must be reduced by:
 - Seventy-five percent for the second taxable year of operation of the transmission linegathering pipeline.
 - 2. Fifty percent for the third taxable year of operation of the transmission linegathering pipeline.
 - 3. Twenty five percent for the fourth taxable year of operation of the gathering pipeline or collection system.
- 23 After the fourth taxable year of operation the gathering and collection systems are no longer 24 exempt, in any way, from payment of full property taxes as otherwise determined by law. For

1	purposes of this section, "initially placed in service" includes both new construction and
2	substantial expansion of a preexisting gathering or collection system, and "substantial
3	expansion" means a capacity increase of twenty percent or more. Associated equipment
4	includes compression, liquid separation facilities, and any other equipment absolutely
5	necessary to gather or collect natural gas and natural gas liquids. A "collection system" is a
6	system that collects at least seventy-five percent of the gas and natural gas liquids from the well
7	for compression to liquid or dense phase fluid for use as fuel or transport to a processing facility,
8	production of petrochemicals or fertilizer, or conversion to liquid fuels. Natural gas processing
9	and other natural gas liquid refining plants or facilities are expressly excluded from this section.
10	SECTION 2. A new subsection to section 57-51-02.2 of the North Dakota Century Code is
11	created and enacted as follows:
12	An operator who collects natural gas at a well site by natural gas gathering line,
13	electrical generator, or collection system described in section 38-08-06.4 shall be
14	entitled to an exemption from the tax imposed under this section for a period of one
15	year from the day the natural gas is first collected.
16	SECTION 3. EFFECTIVE DATE. Section 1 of this Act is effective for taxable years
17	beginning after December 31, 2012. Section 2 of this Act is effective for taxable events
18	occurring after June 30, 2013.
