## REMARKS OF THE HONORABLE SENATOR HEIDI HEITKAMP

Good afternoon and thank you for having me. It's great to be back home in North Dakota, it is such an honor to be your Senator in Washington, but I sure do miss being home. That's why when the Congress has a recess, I make it a priority to get home and around the state as much as possible. Over this next week and a half I will be focusing on our states housing situation by organizing round table discussions with folks in Dickinson, Bismarck, Minot, Williston, Valley City, and Fargo to hear their concerns and bring their solutions with me back to DC.

Housing. I don't have to tell any of you how the housing needs in our state have changed in the last few years. The tremendous energy development we are experiencing has transformed this state and spurred rapid growth, and it's just the beginning. Over the next 12 years North Dakota's population is expected to increase by just over twenty-five percent, concentrated in regions where drilling is occurring. This puts an unprecedented strain on our cities and towns as they struggle to grow while protecting the values and identity unique to their community, not to mention our families as they struggle to afford the skyrocketing rent and housing costs. These housing and growth challenges in North Dakota are complicated, but they also present us with an exciting opportunity. The opportunity to drive unprecedented economic growth and build sustainable communities that we can be proud of and raise our families in, the North Dakota way. But in order to realize that opportunity we have much work to do.

Some of you may know that I sit on the Senate Banking Committee, which has oversight of the housing industry. This puts me in a strong position to advocate for rural housing needs and bringing home real solutions. Solutions like pushing the Department of Housing and Urban Development to update our Fair Market Housing rents to the Housing Choice Voucher program, which would bring relief to low and moderate income households, especially out west where affordable housing is harder and harder to find - or finding ways to use the Moving to Work Program, a demonstration program for public housing authorities that would provide opportunity to design and test innovative, locally designed strategies that use federal dollars more efficiently. My focus will be on working with you back home to bring this issue front and center into the process while we're at it.

Agriculture. Common sense seems to be in short supply in Washington, DC, which I know has a real impact on hard working people in our state. You will think that giving our farmers a five year Ag bill, so they can plan for their future responsibly, would be common sense, but sadly. Even that is up for debate. That is why the very first piece of legislation I cosponsored was the 2013 Farm Bill. The bill reforms food and agriculture policy, consolidates programs and saves taxpayers billions by making programs more cost effective. As a member of the Senate Agriculture Committee and Chair Woman of the sub committee on Jobs, Rural Economic Growth and Energy Innovation, you can count on me to get up every day and fight for our farmers in North Dakota and to secure a five year Farm Bill this year, a farm bill that maintains the safety net for our farmers while ensuring they aren't undercut by foreign subsidized agriculture.

There is a lot that my friends in DC could learn about the way we do business in North Dakota. We take a lot of pride in the way we get things done here and what we have to offer the rest of this great country.

**Energy.** Here we all know of a real energy renaissance happening in North Dakota. Washington and the rest of our country are starting to take notice. While the oil and gas play out in the Bakken garners all of the headlines, I love to tell my colleagues that we are also big on wind, biofuels, and lignite coal and we are looking into geothermal and next-generation advanced cellulosic. North Dakota is truly an all-of-the-above state. Responsible regulation and development ate buzz words that you frequently hear when it comes to energy extraction and production methods--well, I think we're doing pretty darn good here in North Dakota and when you do things the right way, we should not be looking for additional and redundant layers of bureaucracy to slow down a process that works just fine.

North Dakota continues to be the proving ground for several advanced and innovative

technologies that are revolutionizing the energy industry; the rest of the country now looks to us for proven methods and technologies that can be used in other states to help move the country even closer toward North American energy independence. Senator Hoeven and I have already worked across the aisle on numerous energy issues as we look to craft smart policy that will take advantage of the abundant resources here in North Dakota and around the country. I look forward to continuing that close relationship on these issues as Senator Hoeven and I look to show the rest of the country how we can craft smart, bipartisan energy policies.

Indian Country. As rich as we are in our energy resources, so are we rich in our proud Native American culture. I am so honored to be representing not only the state of North Dakota, but the sovereign Indian nations that are also a part of this great state. I will be relentless in my advocacy for Indian Country, and tirelessly work to find solutions to their issues. Shortly after I arrived in Washington I co-sponsored a piece of legislation that was absolutely critical to protecting women in Indian Country - the Violence Against Women Act. This legislation would finally enable law enforcement and the tribal legal system to have the ability to step in and arrest and prosecute non-Indian domestic abusers who all too often have used our reservations as safe havens from prosecution for their violent and abusive behavior. The President has now signed VAWA into law, and those safe-haven days are over.

I will work to find creative ways to bring additional housing resources and economic development programs to the reservations. All too often we focus on the specialized programs carved out for Indian Country and ignore the many successful programs already in place that can also be used to improve the conditions in Indian Country. While North Dakota continues to be the envy of the nation in many respects, we must not forget our fellow North Dakotans that all too often have been relegated to secondary status. That will not be the case on my watch.

**Flod Control.** Secure, permanent and comprehensive flood protection for the city of Fargo is so important, and I will not be shy about pushing for this absolutely essential protection for our state. Fargo is the largest city along the Red River that does not have a permanent flood protection project. As we face another major flood this year, the importance of this project cannot be understated. The federal government has already provided more than \$26 million to advance the project to date. Recently, I was joined by my colleagues, Senators Hoeven, Klobuchar, and Franken in urging the Senate Committee on Environment and Public Works to include authorization for the Fargo project - the Water Resources Development Act (WRDA). I am pleased that the committee recognized the importance of this project and included authorization for it in the WRDA bill it approved last week. After more than five years without a Water Resources Development Act, this project is now on track to be authorized by Congress. While there are a number of steps yet to go in the process, I am hopeful we will get this authorization through the full Senate and House of Representatives. However, it isn't just Fargo that needs flood control, I am also working to advance flood protection projects for the city of Grafton and the Souris River Basin along with continued efforts to mitigate the flooding in the Devils Lake Basin.

Air Bases. You know in North Dakota we have so much to be proud of, a growing economy, a unique and diverse culture and a way of doing things that values common sense, strong values and integrity, collaboration and good old fashioned hard work. That's why I think we value our Air Force and National Guard bases and military personnel so much, they represent all of those ideals so well. Time and time again when our state and our country have called, they are the first to stand up and say "send me". Their courage, commitment and sacrifice are inspiring. As your Senator I will work every day to protect the military assets we have. I will fight to prove to Air Force leadership that Grand Forks Air Force base is the ideal location for the KC-46A beddown mission. To ensure that the North Dakota Air Guard and the Happy Hooligans of the 119th, one of the Air Guards most successful units, keep a manned flight mission and to defend the absolutely critical nuclear deterrence mission that Minot Air Force base so capably provides.

I want to just close by saying thank you all so much for having me here today and listening to the things I am working on in Washington. I want to also leave you with this task as well. While you're out there hearing from the people you represent think about what we can do together. I want to work with you as much as possible because at the end of the day, everyone here has the same goal: the best North Dakota possible. So don't hesitate to reach out to my staff in the state or call them up in DC, you're hearing from North Dakotans and we are too, so let's see what we can do together to make a real difference.

  - Data regarding the retention rates of students between the fall and spring semesters at any institution within the university system;
  - c. (1) Data regarding the number of students awarded degrees, certificates, or diplomas at each institution during an academic year; and
    - (2) A comparison of the data required by this subdivision with that of peer institutions;
  - d. <u>Information regarding each institution's progress toward meeting its</u> goals and the implementation steps and timelines outlined in the university system's strategic plan;
  - e. Data regarding the number of students that initially enroll at a twoyear institution and obtain a certificate or diploma within three years of enrollment:
  - <u>f.</u> <u>Data regarding the number of students that initially enroll at a four-year institution and obtain a degree:</u>
    - (1) Within four years of enrollment;
    - (2) Within four to five years of enrollment; and
    - (3) Within six years of enrollment;
  - g. <u>Data regarding the number of students that are eligible for Pell grants and:</u>
    - (1) Initially enroll at a two-year institution and obtain a certificate or diploma within three years of enrollment;
    - (2) <u>Initially enroll at a two-year institution and obtain a certificate or diploma within three to four years of enrollment; or</u>
    - (3) Initially enroll at a four-year institution and obtain a degree within four to six years of enrollment; and
  - <u>Data regarding the number of students that are not eligible for Pell</u> grants and:

- (1) Initially enroll at a two-year institution and obtain a certificate or diploma within three years of enrollment;
- (2) Initially enroll at a two-year institution and obtain a certificate or diploma within three to four years of enrollment; or
- (3) Initially enroll at a four-year institution and obtain a degree within four to six years of enrollment.
- 3. a. The report required by subsection 2 must categorize the required information by resident and nonresident students at each institution within the university system and must compare the information to national benchmarks.
  - b. Individuals who are enrolled in personal enrichment courses for which credit is not offered and individuals who audit courses are not eligible to be counted as students for purposes of this report.

**SECTION 2. PERFORMANCE AUDIT.** During the 2013-14 interim, the state auditor shall examine the accountability and performance measures established for the North Dakota university system to determine if they allow for a sufficient, objective, and systemic assessment of economies, efficiencies, and structural effectiveness."
