REMARKS OF ELECTRONICS TECHNICIAN MASTER CHIEF PETTY OFFICER**TIM PREABT****CHIEF OF THE BOAT, USS NORTH DAKOTA (SSN-784)**

Mr. President and Members of the North Dakota Senate:

I bring you greetings from our Commanding Officer, Captain Douglas V. Gordon and the entire crew of the USS NORTH DAKOTA.

Presenting this report on the current status of our boat, you bestow a great honor upon me and those who serve on the USS NORTH DAKOTA, and I am deeply honored.

I was born in Minot and grew up in Williston and Mandan. As a boy, when we traveled out of state, I was always taken back a bit when people – looking at our license plate – would ask, "Where's North Dakota, what's in North Dakota?"

Well, I'm here to tell you – traveling throughout the world – people sure know about North Dakota today!

People know North Dakota is at the forefront of making our nation energy independent. They're aware of our tremendous contribution to food production – and NOW, they are aware of the awesome power North Dakota represents in our national security, with the commissioning of the USS NORTH DAKOTA – the most modern and lethal attack submarine the world has yet to see.

I am here to tell you now, the USS NORTH DAKOTA is already legendary because of all your substantial and loyal support. Captain Gordon and our entire crew very much appreciate all you have done for us.

Many Navy officers and sailors have seen warships commissioned, but I join with Captain Gordon and our entire crew in declaring we have never seen more namesake state support for any commissioning.

Your support as legislators, the tireless work of the people of North Dakota, and the excellent planning of the USS NORTH DAKOTA Committee made our October 25th commissioning an outstanding success!

We were all pleased so many North Dakotans enthusiastically and proudly came out for the commissioning. Everything was perfect, and of course the good weather you North Dakotans brought us really helped. All of us and our families and friends were honored and pleased with the wonderful party you hosted for us that evening after our commissioning.

Our crew was proud to provide a thorough tour of our boat to all those who want to see the workings of their attack sub. I know many North Dakotans spent an hour or more on their tours, and we enjoyed showing off what a great boat we have!

Your USS NORTH DAKOTA is now training and conducting exercises to work up for her first deployment. Rest assured NORTH DAKOTA will serve with distinction, and she will reap any threats from the deep. Through you and the great people of North Dakota, your boat will continue to draw strength from the soil.

May we always mutually cherish and support continuing strong links binding NORTH DAKOTA with her namesake – the people and the State of North Dakota. Your continuing support throughout NORTH DAKOTA's 33 years of expected service life will inspire every submarine sailor who will sail with her into harm's way.

In token of our appreciation for your strong and loyal support, and on behalf of Captain Gordon and his crew, I am pleased to present you with this Honorary Plank Owner plaque. This plaque carries on a great Navy tradition from the days of wooden warships in which the first crew members of every US Navy warship were said to each own a plank of the ship. You have earned the proud ownership of one of our "planks."

Again, it is a great honor for me to serve as a submarine sailor in the United States Navy, and an even greater honor to have served as the first Chief of the Boat of the second warship named for our great state – the USS NORTH DAKOTA.

Affixing a three-digit identification number, assigned by the agriculture commissioner, to the uppermost box of a hive that is visible upon approach to the apiary's main entrance, provided each digit is at least three inches [7.62 centimeters] high, one-half inch [1.27 centimeters] wide, and weather-resistant; and
 - b. Displaying the beekeeper's name and phone number in a location that is visible upon approach to the apiary's main entrance, provided the numbers and letters used are at least one and one-half inches [3.81 centimeters] high and weather-resistant."

Page 4, line 27, after "commissioner" insert "shall"

During the 2015-17 biennium, the office of management and budget shall administer a grant program to political subdivisions that apply for funding for the settlement of claims that are a result of this Act. Under section 32-12.1-03, the liability limit of five hundred thousand dollars for injury to three or more persons during any single occurrence does not apply to a political subdivision for an occurrence on January 5, 2015, to the extent the political subdivision settles the claims within the grant awarded under this Act. If asserted claims exceed the grant award, the political subdivision may reduce the settlement of the claims on a pro rata basis. To qualify for a grant under this section, after receiving claims, a political subdivision shall submit an application with the office of management and budget. Any claim against a political subdivision under this Act must be paid by June 30, 2017. This section does not expand a political subdivision's liability beyond the amount of a grant awarded to the political subdivision under this section.

SECTION 2. APPROPRIATION. There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$2,000,000, or so much of the sum as may be necessary, to the office of management and budget for the purpose of making grants to political subdivisions under section 1 of this Act, for the biennium beginning July 1, 2015, and ending June 30, 2017.

SECTION 3. RETROACTIVE APPLICATION. This Act applies retroactively to an event occurring on January 5, 2015."

SECTION 1. AMENDMENT. Section 49-23-01 of the North Dakota Century Code is amended and reenacted as follows:

49-23-01. Definitions.

As used in this chapter, unless the context otherwise requires:

1. "Abandoned" means no longer in service and physically disconnected from a portion of the facility or from any other facility that is in use or still carries services.
2. "Board" means the board of directors of the nonprofit corporation governing the notification center under section 49-23-03.
3. "Careful and prudent manner" means excavating within twenty-four inches [60.96 centimeters] of the outer edges of an underground facility located manually and marked by the owner or operator by stakes, paint, or other customary manner, and supporting and protecting the uncovered facility.
4. "Damage" means:
 - a. Substantial weakening of structural or lateral support of an underground facility;
 - b. Penetration, impairment, or destruction of any underground protective coating, housing, or other protective device; or
 - c. Impact with or the partial or complete severance of an underground facility to the extent that the facility operator determines that repairs are required.
5. "Emergency" means a sudden, unexpected occurrence, involving a clear and imminent danger, and demanding immediate action to prevent or mitigate loss of, or damage to, life, health, property, or essential public services.

6. "Emergency responder" means a fire department, a law enforcement officer, or other emergency rescue service.
7. "Excavation" means any operation in which earth, rock, or other materials in or below the ground is moved or otherwise displaced by means of hand or power tools, power equipment, or explosives and includes grading, trenching, digging, ditching, drilling, augering, tunneling, boring, scraping, and cable or pipe plowing and driving. The term does not include:
 - a. Opening a grave in a cemetery.
 - b. Plowing, cultivating, planting, harvesting, and similar operations in connection with agricultural activities, unless any of these activities disturbs the soil to a depth of eighteen inches [45.72 centimeters] or more.
 - c. Gardening and landscaping unless it disturbs the soil to a depth of twelve inches [30.48 centimeters] or more.
 - d. Normal maintenance of roads and streets if the maintenance does not change the original grade and does not involve the road ditch.
 - e. Normal repair and maintenance of track and track bed by a railroad on its own right of way.
8. "Excavator" means a person who conducts excavation.
9. "Holiday" means New Year's Day, Martin Luther King Day, Presidents' Day, Good Friday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans' Day, Thanksgiving Day, and Christmas Day. When a holiday falls on a Saturday, it is observed on the preceding Friday as if the Friday were the holiday, and when a holiday falls on a Sunday, it is observed on the following Monday as if the Monday were the actual holiday.
10. "Local governmental unit" means a county, township, or city.
11. "Locate" means an operator's markings of an underground facility showing the approximate horizontal location, including all lines, line direction, intersections, tees, and lateral facilities.
12. "Nonprofit corporation" means a corporation established under chapter 10-33.
13. "Notification center" means a center that receives notice from an excavator of planned excavation or any other request for location and transmits this notice to a participating operator.
14. "Tangible marking materials" means any material perceptible by touch used to mark the location of an underground facility, including flags, stakes, poles, or other materials inserted into or affixed to the ground. The term does not include paint, chalk, or other liquid ink-based materials applied to the ground.
15. "Operator" means a person who owns or operates an underground facility, including a master meter operator with underground facilities, or a state or local governmental entity. The department of transportation is considered an operator for the department's facilities buried on the department's rights of way. A person is not considered an operator solely because the person is an owner or tenant of real property where underground facilities are located if the underground facilities are used exclusively to furnish services or commodities on that property.

- ~~45-16.~~ "Underground facility" means an underground line, pipeline, cable, facility, system, and its appurtenances used to produce, store, convey, gather, transmit, or distribute communications, data, electricity, power, television signals, heat, gas, oil, petroleum products, carbon dioxide, water, steam, sewage, hazardous liquids, and other similar substances. Privately owned and operated underground facilities which do not extend beyond the boundary of the private property are excluded.
- ~~46-17.~~ "Unexpected occurrence" includes a fire, flood, earthquake or other soil or geologic movement, riot, accident, damage to a subsurface installation requiring immediate repair, or sabotage.
- ~~47-18.~~ "Water" includes potable water, wastewater, and storm water.

SECTION 2. AMENDMENT. Subsection 3 of section 49-23-05 of the North Dakota Century Code is amended and reenacted as follows:

3. Assume ownership of materials used to mark the facility, use reasonable efforts to maintain markings during excavation, and ~~when possible-~~ remove all tangible marking materials used to mark the facility upon completion of the excavation."

Inspection of pipelines.

Any person engaged in the construction, operation, or servicing of an underground gathering pipeline, including a produced water pipeline, shall allow the commission, the division of oil and gas of the industrial commission, and any representative of the same to enter any lease, property, and pipeline right of way operated or controlled by that person and to review any record and the operation of the pipeline. The person shall file any requested records with the commission. If the commissioner receives data under this section which is confidential under section 38-08-26, that data retains its confidential status."
