Performance has always been a part of Jacky's life. Growing up singing, dancing, and acting equipped Jacky with the skills for success not just in pageantry but professionally as well. Drama and music shaped Jacky's communication skills, self-confidence, discipline, work-ethic and many other qualities that competing in the Miss America Organization has enhanced.

While competing on the national stage for the Miss America Crown, in an exciting last-minute Judge's Choice save, Jacky was selected to join the Top 16 women moving on in the competition on Finals Night. Jacky was also voted Miss America's Miss Congeniality by her peers, which is certainly a testament to her character.

As a student at Bethel University in St. Paul, Jacky is an honors scholar and a double-major in Political Science and Biblical & Theological Studies. She served as a student senator both her freshman and sophomore years at Bethel before being elected Student Body Vice President her junior year. After completing her undergraduate degrees, Jacky would like to attend law school and build a career in foreign policy working in both women's rights and diplomacy.

**REMARKS OF JACKY ARNESS  
MISS NORTH DAKOTA 2014**

Mr. President and Distinguished Senators:

I got involved with the Miss America Organization my sophomore year at Bethel University. I'm a senior Honors Program double-major in Political Science and Biblical & Theological

Studies. Though I'm taking the year off to fulfill my duties as Miss North Dakota, I will wrap up my undergraduate studies after this year. After graduating I hope to return to the Middle-East, where I spent time studying in 2013, and learn Arabic. I then plan to attend Law School focusing on International Law. As of right now I foresee myself either working in foreign policy, or for a non-profit or private firm in litigation and mediation. While at Bethel I served as a Freshman and Sophomore Senator, and my Junior year I served as Student Body Vice President, in addition to other campus activities.

Getting to represent my home state at the Miss America competition was one of the greatest honors of my life, and I anticipate that it will always be one of my life's highlights. I was selected as the "Judge's Choice" finalist for the Top 16, and represented North Dakota live on ABC on September 14th. This is a time of great change for North Dakota, I know that that is no secret, especially at a gathering such as this. Thus, I was thrilled and proud to represent North Dakota on the national stage at a time when we are making headlines and waves all over the country. But an even greater honor came earlier that evening. I was selected by my peers to receive the Miss Congeniality award, and for the first time in television history, this award was presented live as part of the televised pre show. To be chosen as Miss Congeniality our chairman and CEO described the young woman as needing to be the most "positive, helpful, inspirational, and the young woman that the others love the most". Flattering words to be sure, and to say that I was overwhelmingly humbled and thrilled would still be an understatement. This is a group of women whom I admire, respect, and love beyond articulation, at least in the time I have with you today.

I was also selected as Miss Congeniality both years that I competed for Miss North Dakota. All this being said, I often get asked "why" I believe others chose me. I've more often than not been at a loss as to an explanation for why I feel others voted for me and not someone else, but such inquiries have caused me to give it considerable thought. I showed up at Miss America just like anyone else. I came to do my best and represent myself, my state, and my organization, but I also came prepared to have the best experience of my life. I knew that every day I woke up at Miss America was going to be the new best day of my life. I got to spend a special and unique time with remarkable women who will be some of my life-long best friends. Being there for them and supporting them as we all went through this wonderful, but stressful, experience together was incredibly important to me.

So what has my "considerable thought" provided me with? Well I'll tell you. Growing up in North Dakota has been a privilege. I firmly believe that the opportunities provided here and the general culture of neighborliness, kindness and generosity shaped me into the person I am today. I've never known any other way to treat people than to listen to them and learn their stories, identify common ground, build consensus, be an aid and resource in times of need, strive for excellence and care deeply about the condition of others. Living in North Dakota provided that fertile and supportive environment. To say it more plainly, I guess I have always lived my life in a "state of congeniality".

After the Miss America competition, some of my primary responsibilities include representing and advocating for the Miss North Dakota Scholarship Organization, and speaking with students in our North Dakota schools. Thus far, I've been able to speak with over 15,000 students and discuss issues that are important to me such as relationship building, leadership, failure, goal-setting, and positive decision making.

What I emphasize with students is that the choices that they make today will largely determine the opportunities that are available to them in the future. Their actions and words matter. Though in my school presentations I use words like "friendship" and "leadership", the academic foundation of my message is the idea of "culture creation". At developmentally appropriate levels, I address that as individuals we are either actively or passively involved in creating and/or perpetuating the environments we participate in every single day. Individual persuasions and actions translate into group opinions and actions. How we present ourselves and how we treat others matters. Our contributions to society can either be positive or negative, as can our lack of contribution. Am I creating something valuable? Am I benefiting the broader community? What am I helping to build that will last? Good leaders, I tell students, are not influential just because they have a position of leadership. In fact, those things can be quite different. Rather, good leaders set an example for others by making decisions and taking actions that uplift the broader community. I am hoping to get to as many more schools as possible this year because I am passionate about the enthusiasm of students and the impact that they can have.

My belief that collaboration and camaraderie are the most effective tools for change has been solidified by my time in the Miss America Organization. So as a "culture creator" I must ask what my words, what my actions, and what my treatment of others is doing to make my community and make society better. I am responsible. You are responsible. Our students and youth are responsible. We are responsible.

I got involved with the Miss America Organization for the scholarship opportunity. What I stayed for was the people that I met. I think most people who come to our great state would say something similar. They came for the opportunity, but they stayed because of the thing that truly sets North Dakota above the rest, the people. I pray that in this time of great change for us all that we never lose that core identity. I hope we never become a place where others don't feel welcomed, supported, and celebrated. No matter where I live, no matter what I do, my upbringing in North Dakota will always contribute to my worldview. I will strive to live my life in a "state of congeniality". Ladies and Gentlemen, as I close I will pose to you a single question, different than the questions I present to students, but with the same message and intent. "What state do you live in?"

**BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

**SECTION 1.** A new section to chapter 15.1-36 of the North Dakota Century Code is created and enacted as follows:

**School construction loans - Bank of North Dakota.**

1. In addition to any construction loans made available under section 15.1-36-02, the Bank of North Dakota may provide up to two hundred fifty million dollars to eligible school districts for school construction loans.
2. To be eligible for a loan under this section, the board of a school district shall:
  - a. Propose a new construction or remodeling project with a cost of at least one million dollars and an expected utilization of at least thirty years;
  - b. Obtain the approval of the superintendent of public instruction for the project under section 15.1-36-01;
  - c. Receive authorization for a bond issue in accordance with chapter 21-03; and
  - d. Submit a completed application to the Bank of North Dakota.
3. With the advice and consent of the superintendent of public instruction, the Bank of North Dakota shall award the loans in accordance with a prioritization system that gives consideration to:
  - a. Student occupancy and academic needs in the district;
  - b. The age of existing structures to be replaced or remodeled;

- c. Building design proposals that are based on safety and vulnerability assessments;
  - d. Community support;
  - e. Cost; and
  - f. Any other criteria established in rule by the superintendent of public instruction, after consultation with an interim committee appointed by the legislative management.
- 4. The term of a loan under this section is twenty years, unless a shorter term is requested by the board of a school district in its application.
  - 5. The interest rate on a loan under this section may not exceed one percent, until July 1, 2025.
  - 6. If a school district's unobligated general fund balance on the preceding June thirtieth exceeds the limitation set forth under section 15.1-27-35.3, the loan amount to which that district is entitled under this section may not exceed eighty percent of the project's cost.
  - 7. The maximum loan amount to which a school district is entitled under this section is thirty million dollars.

**SECTION 2. APPROPRIATION.** There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$19,697,572, or so much of the sum as may be necessary, to the Bank of North Dakota for the purpose of providing a school construction interest rate buydown program, for the biennium beginning July 1, 2015, and ending June 30, 2017.
