## **ENGROSSED SENATE BILL NO. 2106**

- 1 A BILL for an Act to create and enact chapter 30.1-36 of the North Dakota Century Code,
- 2 relating to the Uniform Fiduciary Access to Digital Assets Act; and to provide for retroactive
- 3 application.

#### 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1.** Chapter 30.1-36 of the North Dakota Century Code is created and enacted as
- 6 follows:
- 7 **30.1-36-01.** Short title.
- 8 This chapter may be cited as the Uniform Fiduciary Access to Digital Assets Act.
- 9 **30.1-36-02. Definitions.**
- 10 <u>In this chapter:</u>
- 1. "Account holder" means a person that has entered into a terms-of-service agreement
  with a custodian and a fiduciary for that person.
- 13 <u>2. "Agent" means an attorney in fact granted authority under a durable or nondurable</u>
  power of attorney.
- 15 <u>3. "Carries" means engaging in the transmission of electronic communications.</u>
- 16 <u>4.</u> "Catalogue of electronic communications" means information that identifies each
- person with which an account holder has had an electronic communication, the time
- and date of the communication, and the electronic address of the person.
- 19 5. "Content of an electronic communication" means information not readily accessible to
  20 the public concerning the substance or meaning of an electronic communication.
- 21 6. "Court" means the district court.
- 7. "Custodian" means a person that carries, maintains, processes, receives, or stores a
  digital asset of an account holder.

1 "Digital asset" means a record that is electronic. The term does not include an 2 underlying asset or liability unless the asset or liability is itself a record that is 3 electronic. 4 9. "Electronic" means relating to technology having electrical, digital, magnetic, wireless, 5 optical, electromagnetic, or similar capabilities. "Electronic communications" means a digital asset stored by an 6 <u>10.</u> 7 electronic-communication service or carried or maintained by a remote-operating 8 computer service. The term includes the catalogue of electronic communications and 9 the content of an electronic communication. 10 "Electronic-communication service" means a custodian that provides to the public the 11. 11 ability to send or receive an electronic communication. 12 <u>12.</u> "Fiduciary" means a person that is an original, additional, or successor personal 13 representative, guardian or conservator, agent, or trustee. 14 <u>13.</u> "Governing instrument" means a will, trust, instrument creating a power of attorney, or 15 other dispositive or nominative instrument. 16 "Information" means data, text, images, videos, sounds, codes, computer programs, <u>14.</u> 17 software, databases, or the like. 18 <u>15.</u> "Power of attorney" means a record that grants an agent authority to act in the place of 19 a principal. 20 <u>16.</u> "Principal" means an individual who grants authority to an agent in a power of 21 attorney. 22 17. "Protected person" means an individual for whom a guardian or conservator has been 23 appointed. The term includes an individual for whom a petition for the appointment of a 24 guardian or conservator is pending. 25 "Remote-computing service" means a custodian that provides to the public computer <u>18.</u> 26 processing services or the storage of digital assets by means of an electronic 27 communications system, as defined in 18 U.S.C. section 2510(14). 28 19. "Terms-of-service agreement" means an agreement that controls the relationship 29 between an account holder and a custodian. 30 20. "Trustee" means a fiduciary with legal title to an asset pursuant to an agreement or 31 declaration that creates a beneficial interest in others.

- the provision by an affirmative act separate from the account holder's assent to other
  provisions of the terms-of-service agreement.
  - 3. A choice-of-law provision in a terms-of-service agreement is unenforceable against a fiduciary acting under this chapter to the extent the provision designates law that enforces a limitation on a fiduciary's access to digital assets which limitation is void under subsection 2.
  - 4. Except as provided in subsection 2, a fiduciary's access under this chapter to a digital asset does not violate a terms-of-service agreement, notwithstanding a provision of the agreement which limits third-party access or requires notice of change in the account holder's status.
    - 5. As to tangible personal property capable of receiving, storing, processing, or sending a digital asset, a fiduciary with authority over the property of a decedent, protected person, principal, or settlor has the right to access the property and any digital asset stored in it and is an authorized user for purposes of any applicable computer fraud and unauthorized access laws.

# 30.1-36-08. Compliance.

- If a fiduciary with a right under this chapter to access a digital asset of an account holder complies with subsection 2, the custodian shall comply with the fiduciary's request in a record for access to the asset, control of the asset, and a copy of the asset to the extent permitted by copyright law.
- 2. If a request under subsection 1 as made by:
  - a. A personal representative with a right of access under section 30.1-36-03, the request must be accompanied by a certified copy of the letter of appointment of the representative, a small estate affidavit, or a court order;
  - <u>b.</u> A guardian or conservator with the right of access under section 30.1-36-04, the
    request must be accompanied by a certified copy of the court order that gives the
    guardian or conservator authority over the digital asset;
  - An agent with the right of access under section 30.1-36-05, the request must be accompanied by an original or a copy of the power of attorney that authorizes the agent to exercise authority over the digital asset and a certification of the agent, under penalty of perjury, that the power of attorney is in effect; and

1		person for so acting and may assume without inquiry the existence of facts stated in				
2		the certification.				
3	<u>6.</u>	A person that in good faith enters into a transaction in reliance on a certification of trust				
4		under subsection 3 may enforce the transaction against the trust property as if the				
5		representations contained in the certification were correct.				
6	<u>7.</u>	A person that demands the trust instrument in addition to a certification of trust under				
7		subsection 3 or excerpts under subsection 4 is liable for damages if the court				
8		determines that the person did not act in good faith in demanding the trust instrument.				
9	<u>8.</u>	This section does not limit the right of a person to obtain a copy of a trust instrument in				
10		a judicial proceeding concerning the trust.				
11	30.1-36-09. Custodian immunity.					
12	A custodian and its officers, employees, and agents are immune from liability for any act					
13	done in	good faith in compliance with this chapter.				
14	<u>30.1</u>	-36-10. Uniformity of application and construction.				
15	<u>In a</u>	oplying and construing this chapter, consideration must be given to the need to promote				
16	uniformi	ty of the law with respect to its subject matter among states that enact it.				
17	<u>30.1</u>	-36-11. Relation to Electronic Signatures in Global and National Commerce Act.				
18	This	chapter modifies, limits, or supersedes the Electronic Signatures in Global and				
19	National Commerce Act, 15 U.S.C. section 7001 et seq., but does not modify, limit, or					
20	supersede section 101(c) of that Act, 15 U.S.C. section 7001(c), or authorize electronic delivery					
21	of any of the notices described in section 103(b) of that Act, 15 U.S.C. section 7003(b).

23	This chapter does not apply to a digital asset of an employer used by an employee in the					
24	ordinary	course of the employer's business.				
25	SECTION 2. RETROACTIVE APPLICATION.					
26	1.	Subject to subsection 2, this Act applies to:				
27		a. A fiduciary or agent acting under a will or power of attorney executed before, on,				
28		or after August 1, 2015;				
29		b. A personal representative acting for a decedent who died before, on, or after				
30		August 1, 2015;

- 1 c. A guardianship or conservatorship proceeding, whether pending in a court or commenced before, on, or after August 1, 2015; and
- d. A trustee acting under a trust created before, on, or after August 1, 2015.
