- 1 A BILL for an Act to create and enact a new section to chapter 43-45 of the North Dakota
- 2 Century Code, relating to loans for certain behavioral health professions; to amend and reenact
- 3 section 43-45-04 of the North Dakota Century Code, relating to duties of the board of addiction
- 4 counseling examiners; to provide for a statement of legislative intent; to provide for reports to
- 5 the legislative management; to provide an appropriation; to provide a continuing appropriation;
- 6 and to provide for a transfer.

## 7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 8 **SECTION 1. AMENDMENT.** Section 43-45-04 of the North Dakota Century Code is
- 9 amended and reenacted as follows:

- 12 a. Administer and enforce the provisions of this chapter.
- b. Evaluate the qualifications of applicants for a license to practice addiction
   counseling and issue licenses under this chapter.
  - c. Establish ethical standards of practice for persons holding a license to practice addiction counseling in this state.
- d. Establish continuing education requirements and approve providers of continuingeducation.
- 19 e. Approve clinical training programs.
- f. Register clinical trainees.
- 21 g. Register interns.
- h. Register clinical supervisors.
- i. Register licensees for private practice.
- i. Approve and administer examinations.

1		<u>k.</u>	Periodically evaluate initial licensure coursework requirements and clinical
2			training requirements to ensure the requirements are up to date and do not serve
3			as an undue barrier to licensure.
4	2.	The	e board may:
5		a.	Adopt rules under chapter 28-32 to implement this chapter.
6		b.	Issue subpoenas, examine witnesses, and administer oaths, and may investigate
7			allegations of practices violating the provisions of this chapter.
8		C.	Recommend prosecution for violations of this chapter to the appropriate state's

22	<u>1.</u>	<u>a.</u>	The Bank of North Dakota shall develop and implement a program under which
23			loans may be provided to qualified individuals participating in a paid or unpaid
24			internship at a licensed substance abuse treatment facility in this state, in order to
25			obtain licensure as an addiction counselor.
26		<u>b.</u>	The Bank of North Dakota shall determine all terms applicable to the time and
27			manner in which loans made under this section must be repaid.
28		<u>C.</u>	Interest on outstanding loans under this section must accrue at the Bank of North
29			Dakota's current base rate, but may not exceed six percent per annum.
30		<u>d.</u>	The maximum loan for which an applicant may qualify under this section is seven
31			thousand five hundred dollars.

1 This subsection is applicable only to individuals beginning an internship after 2 June 30, 2015. 3 <u>2.</u> The Bank of North Dakota shall maintain a revolving loan fund for the purpose of 4 making loans under this section. All moneys transferred into the fund, interest upon 5 moneys in the fund, and payments to the fund of principal and interest on loans under 6 this section are appropriated to the Bank on a continuing basis. 7 SECTION 3. LEGISLATIVE INTENT - ASSESSMENT OF INTERNSHIPS FOR 8 ADDICTION COUNSELORS. The sixty-fourth legislative assembly recognizes that as 9 dedicated funding becomes available in the future, the center for rural health at the university of 10 North Dakota school of medicine and health sciences has the infrastructure, expertise, 11 experience, and established relationships to provide a statewide assessment of viable 12 internship sites for addiction counselors and to implement and provide oversight for such a 13 program, in partnership with academic professionals in addiction counseling. 14 SECTION 4. BOARD OF ADDICTION COUNSELING EXAMINERS - LEGISLATIVE 15 MANAGEMENT REPORT. The board of addiction counseling examiners shall evaluate the 16 initial licensure coursework requirements and clinical training requirements noted in 17 subsection 1 of section 43-45-04. Before July 1, 2016, the board of addiction counseling 18 examiners shall report on the status of the periodic evaluation of those requirements to the 19 legislative management. 20 SECTION 5. APPROPRIATION - TRANSFER - ADDICTION COUNSELOR INTERNSHIP 21 LOAN PROGRAM - REVOLVING FUND. There is appropriated out of any moneys in the 22 student loan trust fund in the state treasury, not otherwise appropriated, the sum of \$200,000, or 23 so much of the sum as may be necessary, which the director of the office of management and

budget shall transfer to the Bank of North Dakota, for purposes of the addiction counselor

internship loan program revolving fund, as created by section 2 of this Act.
