- 1 A BILL for an Act to create and enact a new section to chapter 57-39.2 of the North Dakota
- 2 Century Code, relating to a sales and use tax exemption for clothing; to provide an
- 3 appropriation; and to provide an effective date.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1.** A new section to chapter 57-39.2 of the North Dakota Century Code is created

6 and enacted as follows:

7 Sales tax exemption for clothing - Allocation of replacement revenue to cities and

8 counties - Continuing appropriation.

9 Gross receipts from sales of clothing are exempt from taxes imposed under this chapter.

10 <u>The commissioner shall make annual allocations of funds provided by legislative appropriations</u>

11 <u>among cities and counties imposing sales taxes to offset the lost city and county sales tax</u>

12 revenue from this exemption. The commissioner shall make an annual payment to cities and

13 counties prorated in proportion to the respective shares of each city and county in respect to

14 total annual statewide city and county home rule sales tax collections.

SECTION 2. APPROPRIATION. There is appropriated out of any moneys in the general
fund in the state treasury, not otherwise appropriated, the sum of \$9,500,000, or so much of the
sum as may be necessary, to the tax commissioner for the purpose of allocation in two equal
annual installments to cities and counties under section 1 of this Act, for the biennium beginning
July 1, 2015, and ending June 30, 2017.

7 SECTION 3. EFFECTIVE DATE. This Act is effective for taxable events occurring after
8 June 30, 2015.
