1 A BILL for an Act to create and enact a new chapter to title 21 of the North Dakota Century

2 Code, relating to a political subdivision borrowing funds; and to amend and reenact sections

3 11-11-18, 21-02-01, and 21-03-02 of the North Dakota Century Code, relating to exemptions

4 from statutory provisions for bonds and the definition of revenues.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. AMENDMENT. Section 11-11-18 of the North Dakota Century Code is
7 amended and reenacted as follows:

8 **11-11-18. Board to submit extraordinary outlay to vote.**

9 The board of county commissioners shall submit to the electors of the county at any regular 10 or special election any proposal for an extraordinary outlay of money by the county when the 11 proposed expenditure is greater in amount than can be provided for by the annual tax levies. If 12 the board considers the courthouse, jail, or other public buildings of the county inadequate for 13 the needs of the county or deems it necessary to build a county hospital, and if it is thought that 14 it is not for the best interests of the county to issue bonds to aid in the construction of such 15 buildings or that the construction of such buildings by any other procedure is not for the best 16 interests of the county, it shall submit to the electors of the county, at any regular or special 17 election, the proposal for the construction of a courthouse, jail, or other public building by 18 establishing a building fund to aid in the construction thereof. The requirements of this section 19 shall not apply to lease-purchase agreements authorized by section 24-05-04 or to bank loans 20 authorized in title 21.

A bank loan and terms must be authorized by resolution of the governing body for the 19 political subdivision. The resolution must identify the revenue to be used to repay the loan and 20 any collateral that will secure repayment of the loan. The loan agreement must be signed on 21 behalf of the political subdivision by the president, chairman, or equivalent officer; auditor; 22 business manager; and secretary or equivalent officer of the political subdivision. 23 Limit on amount of loans - Loan terms. 24 Except as limited by this section, a bank and political subdivision may agree to terms and 25 conditions of a bank loan, including the rate of interest and any collateral. 26 A political subdivision may have no more than five hundred thousand dollars in <u>1.</u> 27 outstanding principal on bank loans at any time. 28 A political subdivision bank loan must be paid in full within five years from the date of 2. 29 loan origination.

- 1 <u>3.</u> <u>The loan documents must describe the revenues from which the loan is anticipated to</u>
- 2 <u>be paid and may require the political subdivision to establish a separate fund for the</u>
- 3 repayment of the loan, including interest, on or before the due date.
- 4 <u>4.</u> <u>Collateral for a loan may consist only of property that is purchased with loan proceeds.</u>
- 5 **Delinquent loans.**
- 6 If designated revenues are not sufficient to pay a loan balance, in addition to the designated
- 7 revenues, the political subdivision may set aside up to ten percent of the amount of the
- 8 <u>collections from current tax revenues to pay to the lending bank on a monthly basis until the</u>
- 9 delinquent loans have been paid in full.
