- 1 A BILL for an Act to amend and reenact section 50-24.5-01 of the North Dakota Century Code,
- 2 relating to eligibility for basic care assistance; and to declare an emergency.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 **SECTION 1. AMENDMENT.** Section 50-24.5-01 of the North Dakota Century Code is
- 5 amended and reenacted as follows:
- 6 **50-24.5-01. Definitions.**
- 7 In this chapter, unless the context otherwise requires:
- 8 1. "Aged" means at least sixty-five years of age.
- 9 2. "Blind" has the same meaning as the term has when used by the social security
- administration in the supplemental security income program under titles II and XVI of
- 11 the Social Security Act [42 U.S.C. 401-434 and 42 U.S.C. 1381 et seq.].
- 12 3. "Congregate housing" means housing shared by two or more individuals not related to
- each other which is not provided in an institution.
- 14 4. "County agency" means the county social service board.
- 15 5. "Department" means the department of human services.
- 16 6. "Disabled" has the same meaning as the term has when used by the social security
- 17 administration in the supplemental security income program under titles II and XVI of
- the Social Security Act [42 U.S.C. 401-434 and 42 U.S.C. 1381 et seq.].
- 7. "Eligible beneficiary" means a resident of this state who:
- 20 a. (1) Is aged; or
- 21 (2) Is at least eighteen years of age and is disabled or blind;
- b. (1) Has applied for and is eligible to receive and receives benefits under title
- 23 XIX of the Social Security Act [42 U.S.C. 1396 et seq.], and who has applied
- for and is receiving benefits, if the individual is eligible to receive benefits,

3		(2) Has applied for and is eligible to receive and receives benefits under section
4		50-24.1-37 for long-term services and supports pursuant to an asset test
5		established under title XIX of the Social Security Act [42 U.S.C. 1396]
6		et seq.] and section 50-24.1-02;
7		c. Meets the requirements of section 23-09.3-08.1;
8		d. Based on a functional assessment, is not severely impaired in any of the
9		activities of daily living of toileting, transferring to or from a bed or chair, or eating
10		and:
11		(1) Has health, welfare, or safety needs, including a need for supervision or a
12		structured environment, which require care in a licensed adult family foster
13		care home or an assisted living facility; or
14		(2) Is impaired in three of the following four instrumental activities of daily living:
15		preparing meals, doing housework, taking medicine, and doing laundry; and
16		e. Is determined to be eligible pursuant to rules adopted by the department.
17	8.	"Institution" means a facility licensed under chapter 23-09.3.
18	9.	"Living independently" includes living in congregate housing. The term does not
19		include living in an institution.
20	10.	"Personal needs allowance" means an amount retained by the eligible beneficiary to
21		cover the costs of clothing and other personal needs.
22	11.	"Proprietor" means an individual responsible for day-to-day administration and
23		management of a facility.
24	12.	"Remedial care" means services that produce the maximum reduction of an eligible
25		beneficiary's physical or mental disability and the restoration of an eligible beneficiary
26		to the beneficiary's best possible functional level.
27	13.	"Would be eligible to receive the cash benefits except for income" refers to an
28		individual whose countable income, less the cost of necessary remedial care that may
29		be provided under this chapter, does not exceed an amount equal to the cash benefit
30		under titles II and XVI of the Social Security Act [42 U.S.C. 401-434 and

- 1 42 U.S.C. 1381 et seq.] which the individual would receive if the individual had no
- income, plus the amount allowed as the personal needs allowance.
- 3 **SECTION 2. EMERGENCY.** This Act is declared to be an emergency measure.
