1 A BILL for an Act to provide an appropriation for defraying the expenses of the commission on

2 legal counsel for indigents: to amend and reenact subsection 6 of section 54-61-01 of the North

3 Dakota Century Code, relating to the commission on legal counsel for indigents; and to provide

4 <u>for a report to the sixty-fifth legislative assembly</u>.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds 7 as may be necessary, are appropriated out of any moneys in the general fund in the state 8 treasury, not otherwise appropriated, and from special funds derived from other income, to the 9 commission on legal counsel for indigents for the purpose of defraying the expenses of the 10 commission on legal counsel for indigents, for the biennium beginning July 1, 2015, and ending 11 June 30, 2017, as follows:

13	relating to the official business of the commission. A member of the commission who is								
14	a member of the legislative assembly is entitled to receive per diem compensation at								
15	the rate as provided under section 54-35-10 for each day devoted to attending								
16		meetings or performing oth	ner duties relating to the	official business of t	he commission.
