- 1 A BILL for an Act to provide for limitations on the use of an unmanned aerial vehicle for
- 2 surveillance.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 SECTION 1.
- 5 **Definitions.**
- 6 As used in this Act:
- 7 <u>1. "Flight data" means imaging or other observation recording.</u>
- 8 <u>2.</u> "Flight information" means flight duration, flight path, and mission objective.
- 9 <u>3. "Law enforcement agency or agents" has the meaning provided for law enforcement</u> 10 officer in section 12.1-01-04.
- 11 4. "Unmanned aerial vehicle" means any aerial vehicle that is operated without the
- 12 possibility of direct human intervention within or on the aerial vehicle. The term does
- 13 not include satellites.
- 14 5. "Unmanned aerial vehicle system" means an unmanned aerial vehicle and associated
- elements, including communication links and the components that control the
- 16 unmanned aerial vehicle, which are required for the pilot in command to operate safely
- and efficiently in state airspace.
- 18 **SECTION 2.**
- 19 <u>Limitations on use of unmanned aerial vehicle system.</u>
- 20 <u>1. Information obtained from an unmanned aerial vehicle is not admissible in a</u>
- 21 prosecution or proceeding within the state unless the information was obtained:
- 22 a. Pursuant to the authority of a search warrant; or
- b. In accordance with exceptions to the warrant requirement.

7	<u>War</u>	Warrant requirements.		
8	A wa	A warrant for the use of an unmanned aerial vehicle must satisfy the requirements of the		
9	Constitution of North Dakota. In addition, the warrant must contain a data collection statement			
10	that incl	ncludes:		
11	<u>1.</u>	The pe	rsons that will have the power to authorize the use of the unmanned aerial	
12		vehicle		
13	<u>2.</u>	The loc	ations in which the unmanned aerial vehicle system will operate;	
14	<u>3.</u>	The ma	eximum period for which the unmanned aerial vehicle system will operate in	
15		each flight; and		
16	<u>4.</u>	Whether the unmanned aerial vehicle system will collect information or data about		
17		individuals or groups of individuals, and if so:		
18		<u>a.</u> <u>Tr</u>	ne circumstances under which the unmanned aerial vehicle system will be

24		<u>(1)</u>	The period for which the information or data will be retained; and

27	SECTION 4.			
28	Exceptions.			
29	This Act does not prohibit any use of an unmanned aerial vehicle for surveillance during the			
30	course of:			

- 1. Patrol of national borders. The use of an unmanned aerial vehicle to patrol within
 2 twenty-five miles [40.23 kilometers] of a national border, for purposes of policing that
 3 border to prevent or deter the illegal entry of any individual, illegal substance, or
 4 contraband.
- Exigent circumstances. The use of an unmanned aerial vehicle by a law enforcement
 agency is permitted when exigent circumstances exist. For the purposes of this
 subsection, exigent circumstances exist when a law enforcement agency possesses
 reasonable suspicion that absent swift preventative action, there is an imminent
 danger to life or bodily harm.
 - 3. An environmental or weather-related catastrophe. The use of an unmanned aerial vehicle by state or local authorities to preserve public safety, protect property, survey environmental damage to determine if a state of emergency should be declared, or conduct surveillance for the assessment and evaluation of environmental or weather-related damage, erosion, flood, or contamination.
 - 4. Research, education, training, testing, or development efforts undertaken by or in conjunction with a school or institution of higher education within the state and its political subdivisions, nor to public and private collaborators engaged in mutually supported efforts involving research, education, training, testing, or development related to unmanned aerial vehicle systems or unmanned aerial vehicle system technologies and potential applications.

SECTION 5.

Prohibited use.

- 1. A law enforcement agency may not authorize the use of, including granting a permit to use, an unmanned aerial vehicle armed with any lethal weapons.
- 2. This Act prohibits any use of an unmanned aerial vehicle for:
 - a. Domestic use in private surveillance. A law enforcement agency may not authorize the use of, including granting a permit to use, an unmanned aerial vehicle to permit any private person to conduct surveillance on any other private person without the express, informed consent of that other person or the owner of any real property on which that other private person is present.

1 Surveillance of the lawful exercise of constitutional rights, unless the surveillance 2 is otherwise allowed under this chapter. A state agency may not authorize the 3 use, including granting a permit to use, of an unmanned aircraft for the purpose 4 of the surveillance of persons engaged in the lawful exercise of the constitutional-5 right of freedom of speech and freedom of assembly. 6 **SECTION 6.** 7 Documentation of unmanned aerial vehicle use. 8 The person authorized to conduct the surveillance under this Act shall document all <u>1.</u> 9 use of an unmanned aerial vehicle for surveillance. The person shall document all 10 surveillance flights as to duration, flight path, and mission objectives. 11 <u>2.</u> The flight information must be verified as accurate and complete by the supervising 12 person authorized by a court to conduct the surveillance. 13 The flight information required under this section must be retained for five years. 3. 14 Any imaging or any other forms of data lawfully obtained under this Act which are not <u>4.</u> 15 accompanied by a reasonable and articulable suspicion that the images or data 16 contain evidence of a crime, or are relevant to an ongoing investigation or trial, may 17 not be retained for more than ninety days. 18 <u>5.</u> Except for the operational capabilities of the unmanned aerial vehicle system and 19 other operational information strictly related to the technical conduct and physical 20 security of the surveillance operation, a person accused of a crime that includes 21 evidence gathered through the use of an unmanned aerial vehicle system surveillance 22 may obtain all information relating to the person acquired in the course of the 23 surveillance through subpoena and discovery proceedings available in criminal
