- 1 A BILL for an Act to create and enact chapter 23-48 and a new section to chapter 50-24.1 of the
- 2 North Dakota Century Code, relating to the certification of a community health
- 3 worker-community health representative and to medical assistance reimbursement.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1.** Chapter 23-48 of the North Dakota Century Code is created and enacted as

6 follows:

10		community health worker-community health representative who is certified under this

13		direct services that are aimed at optimizing individual and family health and dental				
14		outcomes, and which may include:				
15		a. Informal and motivational counseling and education;				
16		b. Interventions to maximize social supports;				
17		c. Participation in care coordination;				
18		d. Participation in case management:				
19		e. Facilitation of access to health care, dental care, and social services;				
20		f. Health and dental screenings; and				
21		g. Other services as permitted by rule.

Fees. 4 The department shall deposit fees collected under this chapter in the department's 5 operating fund. 6 23-48-06. Initial certification - Waiver of criteria. 7 An applicant for certification shall submit to the department an application and 1. 8 associated fees at the time and in the manner required by the department. 9 The department may waive one or more certification criteria in the case of an <u>2.</u> 10 individual who provides satisfactory evidence of health care training, work experience, 11 or other education, comparable to the certification standards required by this chapter. 12 3. An individual seeking a waiver of criteria in accordance with subsection 2 shall 13 demonstrate familiarity with the community health worker-community health 14 representative program in this state and shall agree to limit the individual's practice to 15 this state. 16 A certificate issued under this section is valid for three years. 4. 17 23-48-07. Certification - Renewal. 18 <u>1.</u> An applicant for certification renewal shall submit to the department an application and 19 associated fees for certification renewal. Each individual is responsible for ensuring 20 that the renewal of certification is completed in a timely manner. 21 2. The department shall issue a renewal certificate that is valid for three years to each 22 qualified applicant. 23 <u>3.</u> As a condition of certification renewal, the department shall require an applicant to 24 complete ten hours of approved continuing education each year. 25 23-48-08. Certified community health worker-community health representative -26 Scope of practice. 27 1. A certified community health worker-community health representative may engage 28 only in those activities authorized in this chapter and rules adopted under this chapter. 29 While practicing as a certified community health worker-community health 30 representative, an individual may not engage in or perform any act or service for which 31 another professional certificate, license, or other legal authority is required.

1	<u>2.</u>	This chapter does not prevent or restrict the practice, service, or activities of any			
2		individual simultaneously certified as a community health worker and licensed,			
3		certified, registered, or otherwise authorized to engage in the practice of another			
4		profession in this state, if that individual does not use, while engaged in the authorized			
5		practice of another profession, any name, title, letter designations, or any other			
6		designation indicating that the individual is a certified community health			
7		worker-community health representative.			
8	SECTION 2. A new section to chapter 50-24.1 of the North Dakota Century Code is created				
9	and enacted as follows:				
10	Medical assistance coverage - Certified community health worker-community health				
11	representative.				
12	Medical assistance coverage must include reimbursement of a certified community health				
13	worker-community health representative, as provided for under chapter 23-48, if the individual				
14	provides for the coordination of care and education services and if the services are provided				
15	under the supervision of a physician, a physician's assistant, a registered nurse, an advanced				
16	practice	registered nurse, a behavioral health professional, an optometrist, or a dentist.
