24		term	ns of that contract the nonprofit corporation acquired and constructed a school		
25		facil	ity that the nonprofit corporation in turn leases back to the district for use in the		
26		prov	vision of educational services, that facility is designated as a public facility owned		
27		by t	he school district for purposes of insurability under this chapter.		
28	2.	For	purposes of this section, "school facility" means the real property referenced in the		
29		cont	tract and all buildings, improvements, and fixtures on the real property.		

SECTION 3. APPROPRIATION. There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$19,697,572, or so much of

- 5 **SECTION 4. EXPIRATION DATE.** Section 2 of this Act is effective through June 30, 2017, and after that date is ineffective.
 - **SECTION 5. EMERGENCY.** This Act is declared to be an emergency measure.
