## **ENGROSSED HOUSE BILL NO. 1446**

- 1 A BILL for an Act to create and enact chapter 17-10 and subsection 9 to section 39-12-05.3 of
- 2 the North Dakota Century Code, relating to natural gas fueling stations and weight limitations for
- 3 natural gas vehicles; and to provide an appropriation.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1.** Chapter 17-10 of the North Dakota Century Code is created and enacted as
- 6 follows:
- 7 **17-10-01. Definitions.**
- 8 For purposes of this chapter, unless context otherwise requires:
- 9 <u>1. "Natural gas" means compressed natural gas, liquid natural gas, or propane.</u>
- 10 <u>2.</u> "Retail location" means a site at which natural gas is dispensed through a device from
- 11 <u>a storage tank into a motor vehicle.</u>
- 12 <u>17-10-02. Natural gas fueling station incentive program.</u>
- The department of commerce shall administer the natural gas fueling station incentive
- 14 program to provide cost-share grants of up to a maximum two hundred fifty thousand dollars per
- 15 retail location for equipment and installation of equipment to dispense natural gas at a retail
- 16 location. The department shall establish rules for the program including rules relating to the
- verification of costs, the eligibility of recipients, the application and grant award procedures, and
- 18 <u>reporting requirements.</u>
- 19 <u>17-10-03. Natural gas motor vehicle incentive program.</u>
- 20 <u>The department of commerce shall administer the natural gas vehicle incentive program to</u>
- 21 provide a cost-share grant of up to seven thousand five hundred dollars for the purchase of a
- 22 new noncommercial motor vehicle that uses natural gas as the primary fuel or for the
- 23 conversion of a noncommercial motor vehicle to use natural gas as the primary fuel. The
- 24 <u>department shall provide a cost-share grant of up to fifteen thousand dollars for a new</u>

- 1 commercial motor vehicle that uses natural gas as the primary fuel or for the conversion of a
- 2 <u>commercial motor vehicle to use natural gas as the primary fuel. The department shall establish</u>
- 3 rules for the program including rules relating to the verification of costs, the eligibility of
- 4 <u>recipients, and the application and grant award procedures.</u>
- 5 **SECTION 2.** Subsection 9 to section 39-12-05.3 of the North Dakota Century Code is created and enacted as follows:
  - 9. A vehicle or combination of vehicles that uses natural gas as the primary fuel may operate with an additional two thousand five hundred pounds [1133.98 kilograms]. The additional pounds may be solely for gross weight limits above the legal weight limits.
  - **SECTION 3. APPROPRIATION.** There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$3,000,000, or so much of the sum as may be necessary, to the department of commerce for the purpose of the natural gas motor vehicle incentive program, for the biennium beginning July 1, 2015, and ending June 30, 2017.
  - **SECTION 4. APPROPRIATION.** There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$1,000,000, or so much of the sum as may be necessary, to the department of commerce for the purpose of natural gas fueling station incentive program, for the biennium beginning July 1, 2015, and ending June 30, 2017.
