6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

7 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds

as may be necessary, are appropriated out of any moneys in the general fund in the state

treasury, not otherwise appropriated, to the Indian affairs commission for the purpose of

defraying the expenses of the Indian affairs commission, for the biennium beginning July 1,

11	A North Dakota American Indian business development office is established within the				
12	commission to assist North Dakota American Indian tribal and individual economic development				
13	representatives, businesses, and entrepreneurs with access to state and federal programs				
14	designed to assist these business interests. The commission shall cooperate with the				
15	department of commerce in the administration of the office. The office shall provide services to				
16	assist in the formation of partnerships between American Indian and non-American Indian				
17	businesses. The commission may contract with a third party for the provision of services for the				
18	office. If the commission contracts with a third party under this section, all data and databases				
19	collected and created by the third party in performing services for the office are the property of				
20	the commission and the third party.
