- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
- 2 governor; and to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota
- 3 Century Code, relating to the salaries of the governor and lieutenant governor.

#### 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, to the office of the governor for the purpose of defraying the expenses of the office of the governor, for the biennium beginning July 1, 2015, and ending June 30, 2017, as follows:

12 The 2015-17 one-time funding amounts are not a part of the entity's base budget for the

13 2017-19 biennium. The office of the governor shall report to the appropriations committees of

the sixty-fifth legislative assembly on the use of this one-time funding for the biennium

beginning July 1, 2015, and ending June 30, 2017.

**SECTION 3. APPROPRIATION - GOVERNOR'S OFFICE.** In addition to the amounts appropriated to the governor's office in section 1 of this Act, there is appropriated any additional income from federal or other funds which may become available to the agency for the biennium beginning July 1, 2015, and ending June 30, 2017.

**SECTION 4. AMENDMENT.** Section 54-07-04 of the North Dakota Century Code is amended and reenacted as follows:

## 54-07-04. Salary of governor.

The annual salary of the governor is one hundred twenty-one thousand six hundred eighty-one dollars through June 30, 2014, and one hundred twenty-five thousand three hundred thirty-one one hundred thirty thousand three hundred forty-three one hundred twenty-nine thousand ninety-one dollars through June 30, 2016, and one hundred thirty-five thousand five hundred fifty-sixone hundred thirty-two thousand nine hundred sixty-four dollars thereafter.

**SECTION 5. AMENDMENT.** Section 54-08-03 of the North Dakota Century Code is amended and reenacted as follows:

# 1 54-08-03. Salary of lieutenant governor.

The annual salary of the lieutenant governor is ninety-four thousand four hundred sixty-two
dollars through June 30, 2014, and ninety-seven thousand two hundred ninety-sixone hundred
one thousand one hundred eighty-sevenone hundred thousand two hundred fifteen dollars
through June 30, 2016, and one hundred five thousand two hundred thirty-fourone hundred
three thousand two hundred twenty-one dollars thereafter.
