- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the game and fish
- 2 department; to create and enact a new section to chapter 20.1-08 of the North Dakota Century

3 Code, relating to governor's a gubernatorial proclamation concerning the hunting of elk; to

4 provide for a legislative management study; and to provide an expiration date.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds 7 as may be necessary, are appropriated out of any moneys in the game and fish fund in the state 8 treasury, not otherwise appropriated, and from special funds derived from federal funds and 9 other income, to the game and fish department for the purpose of defraying the expenses of the 10 game and fish department, for the biennium beginning July 1, 2015, and ending June 30, 2017, 11 as follows:

19 line item in section 1 of this Act includes up to \$400,000 received by the game and fish

20 department for surface damage, easements, or reclamation on department owned or managed

21 properties as a result of mineral exploration and extraction activities.

SECTION 3. A new section to chapter 20.1-08 of the North Dakota Century Code is createdand enacted as follows:

24 Governor's proclamation concerning the hunting of elk - Annie's house at Bottineau 25 winter park raffle.

- 26 <u>The governor may by proclamation provide for a season to hunt elk in a manner, number,</u>
- 27 places, and times as the governor prescribes. Licenses to hunt elk must be issued by lottery.
- 28 except as provided under subsection 7 of section 20.1-03-11, with only residents eligible to
- 29 apply; however, the governor may by proclamation make available to Annie's house at
- 30 Bottineau winter park a license to hunt elk in a manner, places, and times as the governor
- 31 prescribes. Annie's house at Bottineau winter park shall hold a raffle under rules adopted by the

- 1 director with residents and nonresidents eligible to participate. No more than ten percent of the
- 2 gross proceeds of the raffle may be used to promote the raffle and all remaining net proceeds
- 3 must be used to support the operations of Annie's house at Bottineau winter park. Annie's
- 4 house at Bottineau winter park shall submit reports concerning the raffle as the director
- 5 requires. An individual who has been convicted of illegally taking a moose, elk, or bighorn sheep
- 6 <u>is not eligible to receive a license under this section.</u>

SECTION 4. LEGISLATIVE MANAGEMENT STUDY - GAME AND FISH LICENSES.

- 8 During the 2015-16 interim, the legislative management shall consider studying game and fish
- 9 department licenses provided to entities for the purpose of fundraising. The study must include
- 10 a review of the present law in this and other states and the feasibility and desirability of allowing
- 11 the game and fish department to issue these licenses using procedures and within limits
- 12 established by the legislative assembly. The legislative management shall report its findings and
- 13 recommendations, together with any legislation required to implement the recommendations, to
- 14 the sixty-fifth legislative assembly.
- 15 SECTION 5. EXPIRATION DATE. Section 3 of this Act is effective through June 30, 2017,
- 16 and after that date is ineffective.
