The House convened at 1:00 p.m., with Speaker Bellew presiding.

The prayer was offered by Dr. Preston Van Loon, Sanford Chaplain Ministries, Bismarck.

The roll was called and all members were present except Representatives Kempenich and Nathe.

A quorum was declared by the Speaker.

**MOTION**

**REP. VIGESAA MOVED** that a committee of two be appointed to escort Miss North Dakota, Macy Christianson to the podium, which motion prevailed on a voice vote.

**SPEAKER BELLEW APPOINTED** Reps. Karla Hanson and Emily O'Brien to the escort committee.

**REMARKS OF MISS NORTH DAKOTA, MACY CHRISTIANSON**

Mr. Speaker and members of the House. I'm Macy Christianson, Miss North Dakota 2016 and I'm a title-holder with the Miss America Organization. To give a brief summary, it is a scholarship-based organization that is one of the nations leading achievement programs for young women. As Miss North Dakota, I support both a national and personal platform. The national platform of Miss America is Children's Miracle Network and in fact I just got back from running my very first half-marathon in support of CMN.

My personal platform on the other hand is something of my choosing and it's "You Decide the Road Ahead: Don't Drink and Drive." With this I work to not only prevent drinking and driving, but also promote positive decision making especially in North Dakota's young population. I chose this platform because I was able to see first hand how drinking and driving affected my family and community when my older brother made the decision to drink and drive. Through this, I've also had the chance to work with other families that have been impacted by this decision and I've found that while I'm working to impact others, they're impacting me. I've been aiming to spread this across our state through my school tour and any opportunities I'm given to share this message.

The school tour is the biggest and arguably the most important part of my job. I travel this state to various schools and speak on the importance of our decisions. It has been the most fulfilling part of being Miss North Dakota thus far. I love that I'm able to reach some of these students before they're put in harmful situations and hopefully deter them from taking part in things they know are wrong. I've spoken to thousands of students this year and I can only hope that I'm making a difference in their lives and a difference in this state.

Now that I've given you an idea about what I do, I want to talk a little about what you all do. First off, I want to say how proud I am to be from a state where we are keeping important issues in mind and always trying to move in the right direction. I understand that just yesterday there was a hearing for a bill about drinking and driving and there's several others in regards to high-risk alcohol use as well. These are very important issues, especially in our state. That's why it's imperative that we keep these issues in the light and constantly work to fix the problem and I have you all to thank for that. Please continue to listen to these issues not only in regards to drinking and driving, but addiction and alcohol related problems as well.

One aspect that I love in particular about being a title-holder is that I represent such an amazing organization, yet I'm still an individual that can stand for things I'm passionate about and that matter to me. I have immense respect for our state for having taken a stand for what I believe is right in regards to abortion. I've had people tell me that North Dakota

against women and our rights and I have to disagree because not only do we support our women, we also support those women that are unborn that can't speak for themselves. I'm so grateful with this that I can say I'm Miss North Dakota. Just the fact that I can stand here today and have a voice makes me extremely grateful.

A lot of what the Miss North Dakota Organization does is give young women a platform to stand on in their communities. In order to have the chance to compete at the state pageant, girls have to first win a local title. This year we have 25 talented and intelligent young women competing for the job of Miss North Dakota in hopes of getting the opportunities I've been given. Because this resolution was not a delayed bill, but instead a bill introduced upon normal and established deadlines in the rules, according to Joint Rule 203, this bill is past the forty-third legislative day and may not be messaged to the Senate.
