**BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

**SECTION 1.** A new subsection to section 27-20-51 of the North Dakota Century Code is created and enacted as follows:

To the extent necessary to provide victim services or benefits under chapter 12.1-41, the judge and staff of the juvenile court may disclose information to refer a juvenile, who may be a victim of human trafficking, to a staff member of a state or federally administered program for runaway and homeless youth which is located in the state. Information disclosed under this subsection must remain confidential and may not be copied or further disclosed."
