The Senate convened at 1:00 p.m., with President Sanford presiding.

The prayer was offered by Reverend Thomas R. Marcis, Jr., Zion Lutheran Church, Bismarck.

The roll was called and all members were present except Senators Hogue and Sorvaag.

A quorum was declared by the President.

POINT OF PERSONAL PRIVILEGE

SEN. BURCKHARD rose on a point of personal privilege.

REMARKS OF SENATOR BURCKHARD

MR. PRESIDENT: The title of this floor speech is "There's Been Another Three-Peat". As coach Dean Winczewski, the Minot High Magicians basketball coach, said "there are no ugly wins at tournament time" and the team "showed a lot of moxie battling back" as the Magicians trailed at halftime in all three games played in the Boys State Class A Basketball Tournament this past weekend in Bismarck.

The Minot coach would often tell his players, "it's not how you start, but how you finish a basketball game". As Alex Eisen, a sports writer for the Minot Daily News, said "A Magician doesn't rely on luck to dazzle an audience, but rather practice and preparation".

Mr. President, there hasn't been a three-peat in Boys Class A Basketball in 58 years, not since Bismarck Central did it in 1957-1959. Mr. President, you may recall the Bishop Ryan Lions Girls Class B Basketball team pulled off a three-peat in 2013-2015 by winning 83 games in a row. They are from Minot as well.

Mr. President, basketball is a team sport for sure, but two players for Minot High, KyJuan Johnson and Justin Engg, played on all three championship teams. The MHS Magic City campus is located right in the heart of District 5 in Minot. Thousands of fans and I from Magic Town are as proud as we can be of our Magician basketball team. The Boys Class B State Basketball Tournament is in Minot this coming weekend.

I'll conclude this privilege, Mr. President, by saying its good to be from Minot, because "Magic Town is still Title town".

Receive and handle complaints referred to the county auditor by any voter or precinct official involving circulation of petitions, challenges to voters, actions of election officials, or irregularities of any kind in voting. The county auditor shall refer complaints to the secretary of state or the proper prosecuting authority, as the county auditor deems appropriate.

Upon completion of the duties required by this subsection, the county auditor shall certify to the secretary of state, in the manner prescribed by the secretary of state, that the duties have been completed. <u>A knowing</u> violation of this subsection is an offense under section 12.1-11-06.
