- A BILL for an Act to amend and reenact subsections 5 and 7 of section 39-06.1-06,
- 2 paragraph 33 of subdivision a of subsection 3 of section 39-06.1-10, and subdivisions g, h, and i
- 3 of subsection 1 of section 39-09-02 of the North Dakota Century Code, relating to statutory
- 4 fees, entries against driving record, and speed limitations; and to provide a penalty.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Subsection 5 of section 39-06.1-06 of the North Dakota
 Century Code is amended and reenacted as follows:
 - 5. On a highway on which the speed limit is a speed higher than fifty-five miles [88.51 kilometers] an hour, for a violation of section 39-09-02, or an equivalent ordinance, a fee established as follows:

- 15 **SECTION 2. AMENDMENT.** Subsection 7 of section 39-06.1-06 of the North Dakota
- 16 Century Code is amended and reenacted as follows:
- 7. On a highway on which the speed limit is posted in excess of sixty-fiveseventy miles
 [104.61112.65] kilometers] an hour, for a violation of section 39-09-02, or equivalent
 ordinance, a fee of five dollars for each mile per hour over the limit.
- SECTION 3. AMENDMENT. Paragraph 33 of subdivision a of subsection 3 of section 39-06.1-10 of the North Dakota Century Code is amended and reenacted as follows:
- 22 (33) On a highway on which the speed limit is posted in excess of sixty-fiveseventy miles [104.61112.65] kilometers] an hour,
