- A BILL for an Act to amend and reenact sections 43-12.3-01, 43-12.3-05, and 43-12.3-06 of the North Dakota Century Code, relating to a nursing faculty student loan repayment program.
- 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:
- 4 **SECTION 1. AMENDMENT.** Section 43-12.3-01 of the North Dakota Century Code is amended and reenacted as follows:
- 6 43-12.3-01. Student loan repayment programs Health care professionals.
- 7 The health council shall administer student loan repayment programs, as established by
- 8 this chapter, for health care professionals willing to provide services in areas of this state that
- 9 have a defined need for such services or willing to provide services as otherwise provided
- 10 under this chapter.

- 11 **SECTION 2. AMENDMENT.** Section 43-12.3-05 of the North Dakota Century Code is amended and reenacted as follows:
- 43-12.3-05. Health care professionals Selection criteria.
- The health council shall establish criteria to be used in selecting health care
 professionals for participation in a student loan repayment program. The criteria must
 include:
 - a. The health care professional's specialty;
- b. The need for the health care professional's specialty within an area;
- 19 c. The health care professional's education and experience;
- d. The health care professional's date of availability and anticipated term of
 availability; and
- e. The health care professional's willingness to accept medicare and medicaid assignments, if applicable.
