4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1.** A new section to chapter 15-10 of the North Dakota Century Code is created and enacted as follows:
 - Appointment process President of an institution.
- Upon being notified that the state board of higher education must select an individual
 to serve as the president of an institution of higher education under its control, the
 board shall provide for the creation of a presidential search committee.
- 11 2. The board shall:
- a. Establish criteria for the membership of the search committee and the manner in
 which the search committee members are to be appointed;
- b. <u>Define the presidential leadership qualities and qualifications the board desires;</u>
- 15 <u>c. Indicate whether the presidential search is to be regional or national in scope;</u>
- d. Articulate its expectations regarding the selection and use of search consultants;
 and
 - e. Determine the date by which the search committee's recommendations are to be provided to the board.
- 3. The board may not select an individual to serve as the president of an institution
 unless the search committee has presented the board with no fewer than two nor
 more than four candidates, each of whom is qualified by training and experience to
