HB 1163 repeals sections of the Century Code dealing with Sunday closing laws.

If enacted, HB 1163, by repealing certain Sunday closing statutes, will enable retail establishments to open for business Sunday mornings, if they choose to do so. This may increase stores' hours of operation by 3% for mall stores and up to 8% for big box retail 24-hour stores.

Studies indicate a portion of retail trade occurs impulsively, due to the availability and the opportunity to purchases retail items. These types of purchases will result in the possibility of a net positive fiscal impact associated with this bill. It is not possible to estimate this impact, however, as the degree to which retail businesses will choose to open early on Sundays is not known.
