- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of
- 2 public instruction, the state library, the school for the deaf, and the North Dakota vision
- 3 services school for the blind.

### 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the department of public instruction, the school for the deaf, North Dakota vision services - school for the blind, and the state library for the purpose of defraying the expenses of those agencies, for the biennium beginning July 1, 2017, and ending June 30, 2019, as follows:

**SECTION 3. APPROPRIATION - TUITION APPORTIONMENT.** The sum of \$219,134,000, included in the integrated formula payments line item in subdivision 1 of section 1 of this Act, is from the state tuition fund in the state treasury. Any additional amount in the state tuition fund that becomes available for distribution to public schools is appropriated to the department of public instruction for that purpose for the biennium beginning July 1, 2017, and ending June 30, 2019.

# SECTION 4. INTEGRATED FORMULA PAYMENTS AND SPECIAL EDUCATION CONTRACTS EXPENDITURE AUTHORITY. The superintendent of public instruction may expend funds included in the integrated formula payments and grants - special education contracts line items in subdivision 1 of section 1 of this Act in payment of grants for educational services that were due in the 2015-17 biennium but which were not filed, claimed, or properly supported by the education provider until after June 30, 2017.

## SECTION 5. GIFTED AND TALENTED PROGRAM - MEDICAID MATCHING FUNDING - DISTRIBUTION.

- 1. The sum of \$800,000, included in the integrated formula payments line item in subdivision 1 of section 1 of this Act, must be distributed to reimburse school districts or special education units for gifted and talented programs upon the submission of an application that is approved in accordance with guidelines adopted by the superintendent of public instruction. The superintendent of public instruction shall encourage cooperative efforts for gifted and talented programs among school districts and special education units.
- State school aid payments for special education must be reduced by the amount of
  matching funds required to be paid by school districts or special education units for
  students participating in the medicaid program. Special education funds equal to the
  amount of the matching funds required to be paid by the school district or special

3	SECTION 6. REGIONAL EDUCATION ASSOCIATIONS - GRANTS. During the 2017-19			
4	biennium, the superintendent of public instruction shall expend up to \$800,000 from the			
5	integrated formula payments line item in subdivision 1 of section 1 of this Act for the purpose of			
6	providing an annual grant to each eligible regional education association in order to assist each			
7	association with the cost of compensating a coordinator.

The superintendent of public instruction shall use the latest available student 14 enrollment count in each school district in applying the provisions of subsection 1. 15 If any moneys provided for transportation payments in the grants - transportation line 16 item in subdivision 1 of section 1 of this Act, remain after application of the formula 17 provided for in this section, the superintendent of public instruction shall prorate the 18 remaining amounts according to the percentage of the total transportation formula 19 amount to which each school district is entitled. 20 4. This section does not authorize the reimbursement of any costs incurred in providing 21 transportation for student attendance at extracurricular activities or events. 22 SECTION 8. CONTINUING EDUCATION GRANTS - FUNDING - DISTRIBUTION. The 23 sum of \$150,000, or so much of the sum as may be necessary, included in the grants - other 24 grants line item in subdivision 1 of section 1 of this Act is provided for continuing education 25 grants, for the biennium beginning July 1, 2017, and ending June 30, 2019. 26 The superintendent of public instruction shall award grants in amounts up to \$1,200 to 27 eligible recipients in chronological order, based on the date of an individual's 28 application. An eligible recipient must: 29 Be licensed to teach by the education standards and practices board: (1) a. 30 (2) Have taught in this state during each of the last three school years; and

1 (3) Be enrolled at an institution of higher education in this state in either a 2 master of education program in educational leadership or a program leading 3 to a specialist diploma in educational leadership; 4 b. Be pursuing the requirements for a certificate in career development facilitation; 5 or 6 Be pursuing a school counselor credential. C. 7 If any of the amount appropriated for this purpose remains after the superintendent of 8 public instruction has awarded grants to all eligible recipients, the superintendent shall 9 distribute that amount as an additional per student payment on a prorated basis, 10 according to the latest available average daily membership of each school district. 11 SECTION 9. INDIRECT COST ALLOCATION. Notwithstanding section 54-44.1-15, the 12 department of public instruction may deposit indirect cost recoveries in its operating account. 13 SECTION 10. STATE AID TO PUBLIC LIBRARIES. The line item entitled grants in 14 subdivision 2 of section 1 of this Act includes \$2,033,000 for aid to public libraries, of which no 15 more than one-half is to be expended during the fiscal year ending June 30, 2018. 16 SECTION 11. FEES DEPOSITED IN NORTH DAKOTA VISION SERVICES - SCHOOL 17 FOR THE BLIND OPERATING FUND. Any moneys included in the estimated income line item 18 in subdivision 4 of section 1 of this Act, collected for subscription fees or braille fees, must be 19 deposited in the North Dakota vision services - school for the blind operating fund in the state 20 treasury and may be spent subject to appropriation by the legislative assembly. 21 SECTION 12. SCHOOL FOR THE DEAF - HIGHER EDUCATION INTERPRETER GRANT 22 **PROGRAM.** The grants line item contained in subdivision 3 of section 1 of this Act is for the 23 purpose of providing grants to assist institutions under the control of the state board of higher 24 education with the cost of interpreters and real-time captioning for students who are deaf or 25 hard of hearing, for the biennium beginning July 1, 2017, and ending June 30, 2019. Moneys 26 appropriated for this program are not subject to section 54-44.1-11. Funds must be distributed 27 pursuant to the provisions of this section: 28 The school for the deaf shall develop a formula to determine the grant amount for 29 which an institution is eligible. The formula must be based on an uniform hourly

- 2. To obtain a grant under this section, an institution shall submit to the school for the deaf, at the time and in the manner directed by the school, invoices showing the amount expended for interpreters and real-time captioning for students who are deaf or hard of hearing.
  - 3. The school for the deaf may not distribute more than fifty percent of the amount appropriated during the first year of the biennium.
  - 4. If any grant moneys remain undistributed at the end of the biennium, the school for the deaf shall provide additional prorated grants to institutions that incurred, during the biennium, hourly expenses in excess of the formula reimbursement level.
  - 5. At the request of an institution under the control of the state board of higher education, the school for the deaf shall consult with the institution and provide advice regarding the provision of services most appropriate to meet a student's needs.
  - **SECTION 13. OTHER GRANTS REPORTING.** The superintendent of public instruction shall continue reporting on the cost per participant and the outcomes of other grants and report to the sixty-sixth legislative assembly regarding participation, cost, and outcomes of these grants.
