- 9 <u>As used in this Act, unless the context otherwise requires:</u>
- <u>1.</u> <u>"Abuse" means conduct by an applicant, recipient, provider, or other person involving</u>
   <u>disregard of and an unreasonable failure to conform with the laws and rules governing</u>
   <u>the medicaid program if the disregard or failure results or may result in an incorrect</u>
   <u>determination that an individual is eligible for medical assistance or payment by a</u>
- 14 medicaid agency of medical assistance payments to which the provider is not entitled.
- 15 <u>2. "Applicant" means an individual:</u>
- <u>a.</u> Who submitted an application for determination of medicaid eligibility to a.
   <u>medicaid agency on the individual's own behalf or on behalf of another individual;</u>
   <u>or</u>
- 19 <u>D. On whose behalf an application has been submitted.</u>
- 20 <u>3.</u> <u>"Benefit" means the provision of anything of pecuniary value to or on behalf of a</u>
   21 <u>recipient under the medicaid program.</u>
- 22 <u>4.</u> <u>"Claim" means a communication, whether in oral, written, electronic, magnetic, or</u>
- 23 <u>other form, which is used to claim specific services or items as payable or</u>
- 24 reimbursable under the medicaid program or that states income, expense, or other

1		information that is or may be used to determine entitlement to or the rate of payment
2		under the medicaid program. The term includes any documents submitted as part of or
3		in support of the claim.
4	<u> <u>5.     </u></u>	- <u>"Department" means the department of human services.</u>
5	<u> <u>6.    </u></u>	- <u>"Document" means an application, claim, form, report, record, writing, or</u>
6		correspondence, whether in written, electronic, magnetic, or other form.
7	<u> </u>	<u>"Fraud" means any conduct or activity prohibited by law or rule involving knowing</u>
8		conduct or omission to perform a duty that results in or may result in medicaid
9		payments or benefits to which the applicant, recipient, or provider is not entitled.
10	<u> <u> </u></u>	"Medicaid" means the medical assistance program established under chapter 50-24.1.
11	<u> <u>   9.    </u></u>	"Medicaid agency" means any agency or entity of state, county, or local government
12		which administers any part of the medicaid program, whether under direct statutory
13		authority or under contract with an authorized agency of the state or federal
14		government. The term includes the department, the department of corrections and
15		rehabilitation, local offices of public assistance, and other local and state agencies and
16		those agencies' agents, contractors, and employees, if acting with respect to medicaid
17		eligibility, claims processing or payment, utilization review, case management, provider
18		certification, investigation, or other administration of the medicaid program.
19	<u>—<u>10.</u></u>	"Misappropriation of patient property" means exploitation, deliberate misplacement, or
20		wrongful use or taking of a patient's property, whether temporary or permanent,
21		without authorization by the patient or the patient's designated representative. The
22		term includes conduct with respect to a patient's property which would constitute a
23		criminal offense under chapter 12.1-23.
24	<u>—<u>11.</u></u>	"Patient abuse" means the willful infliction of physical or mental injury of a patient or
25		unreasonable confinement, intimidation, or punishment that results in pain, physical or
26		mental harm, or mental anguish of a patient. The term includes conduct with respect to
27		a patient which would constitute a criminal offense under chapter 12.1-16, 12.1-17,
28		<u>12.1-18, 12.1-20, or 12.1-22.</u>
29	<u> <u> </u></u>	"Patient neglect" means a failure, through inattentiveness, carelessness, or other
30		omission, to provide to a patient goods and services necessary to avoid physical
31		harm, mental anguish, or mental illness if an omission is not caused by factors beyond

1	the person's control or by good-faith errors in judgment. The term includes conduct		
2	with respect to a patient which would constitute a criminal offense under section		
3	<u>12.1-17-03.</u>		
4	<u>— 13. "Provider" means a person that enrolled or applied to enroll as a provider of services</u>		
5	or items under medicaid.		
6	<u>14. "Recipient" means an individual:</u>		
7	<u>a. Who has been determined by a medicaid agency to be eligible for medicaid</u>		
8	benefits, regardless of whether the individual has received any benefits; or		
9	<u>b. Who receives medicaid benefits, regardless of whether determined eligible.</u>		
10	- <u>15. "Record" means medical, professional, business, or financial information and</u>		
11	documents, whether in written, electronic, magnetic, microfilm, or other form:		
12	<u>a. Pertaining to the provision of treatment, care, services, or items to a recipient;</u>		
13	b. Pertaining to the income and expenses of the provider; or		
14	<u>c. Otherwise relating to or pertaining to a determination of eligibility for or</u>		
15	entitlement to payment or reimbursement under the medicaid program.		
16	<u>Medicaid fraud control unit.</u>		
17	<u>— The medicaid fraud control unit is established as a division of the attorney general's office.</u>		
18	The medicaid fraud control unit, which is under the supervision and control of the attorney		
19	general, consists of the agents and employees the attorney general considers necessary and		
20	appropriate, including individuals qualified by education, training, experience, and high		
21	professional competence in criminal and civil investigative procedures and high professional		
22	competence to prosecute crimes. The medicaid fraud control unit is a criminal justice agency		
23	within the meaning of section 12-60-16.1. Agents designated by the attorney general have		
24	peace officer status and authority, including the authority of search, seizure, and arrest.		
25	<ul> <li>Powers and duties of medicaid fraud control unit.</li> </ul>		
26	<u>1. The medicaid fraud control unit shall:</u>		
27	a. Investigate and prosecute under applicable criminal laws fraud and abuse by		
28	applicants, recipients, providers, or any other person, including cases referred by

9	All local, county, and state departments and agencies shall cooperate with the medicaid		
10	fraud control unit and the unit's agents and employees to effectuate the purposes of the unit.		
11	SECTION 1. MEDICAID FRAUD CONTROL UNIT STUDY - REPORT TO LEGISLATIVE		
12	MANAGEMENT. During the 2017-18 interim, the department of human services, with the		
13	cooperation of the governor and the attorney general, shall study the feasibility and desirability		
14	of establishing a medicaid fraud control unit. Before August 1, 2018, the department of human		
15	services shall report to the legislative management the outcome of this study, together with any		
16	legislation required to implement the recommendations.
