- 1 A BILL for an Act to amend and reenact subsection 9 of section 12.1-32-02 and subsections 1
- 2 and 5 of section 19-03.1-23 of the North Dakota Century Code, relating to mandatory
- 3 sentences; and to provide a penalty.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. AMENDMENT. Subsection 9 of section 12.1-32-02 of the North Dakota

- 6 Century Code is amended and reenacted as follows:
- 9. A person who is convicted of a felony and sentenced to imprisonment for not more
  than one year is deemed to have been convicted of a misdemeanor upon successful
  completion of the term of imprisonment and a term of probation imposed as a part of
  the sentence. This subsection does not apply to a person convicted of violating
  subdivision a, b, or c or b of subsection 1 of section 19-03.1-23.
- SECTION 2. AMENDMENT. Subsections 1 and 5 of section 19-03.1-23 of the North Dakota
   Century Code are amended and reenacted as follows:
- Except as authorized by this chapter, it is unlawful for any person to willfully, as
   defined in section 12.1-02-02, manufacture, deliver, or possess with intent to
   manufacture or deliver, a controlled substance, or to deliver, distribute, or dispense a
   controlled substance by means of the internet, but any person who violates section
   12-46-24 or 12-47-21 may not be prosecuted under this subsection. Any person who
   violates this subsection with respect to:
- a. A controlled substance classified in schedule I or II which is a narcotic drug, or
   methamphetamine, is guilty of a class A felony and must be sentenced:
  - (1) For a second offense, to imprisonment for at least five years.

1		b.	Any other controlled substance classified in schedule I, II, or III, or a controlled
2			substance analog is guilty of a class B felony. Except for a person who
3			manufactures, delivers, or possesses with the intent to manufacture or deliver
4			marijuana, any person found guilty under this subdivision must be sentenced:
5			(1) For a second offense, to imprisonment for at least three years.
6			(2) For a third or subsequent offense, to imprisonment for tenat least five years.
7		C.	A controlled substance classified in schedule IV, is guilty of a class C felony and
8			must be sentenced:
9			(1) For a second offense, to imprisonment for at least six months.
10			(2) For a third offense, to imprisonment for at least one year.
