This bill removes the Medicaid Expansion sunset and in Section 1 expands the Medicaid estate recovery exclusion for Medicaid Expansion.

The Department's 2017 - 2019 budget in HB 1072 for Medicaid Expansion is at the Medicaid fee schedule rates. The Department did not build the Medicaid Expansion budget at the current commercial rates. HB1259 has no fiscal impact on HB1072.

Section 1 is expected to have minimal impact, which cannot be determined.

Medicaid Expansion has \$6.7 million general fund included in HB1012. (\$8.2 million less the \$1.5 million allotment.) An additional \$23.7 million is estimated to be needed in HB1012 to continue Medicaid expansion at Medicaid rates and operated as fee for service rather than current managed care.
