Over the past two years you have welcomed them to your eternal home. But first you appointed them to serve the citizens of North Dakota and to personify your love and grace by giving them wisdom, discernment, courage, perseverance and integrity.

Their families, their colleagues, their adversaries and all those who knew of them have been blessed by their thirst for justice and righteousness and their selfless dedication to serving others. May the example they lived be an inspiration to all those who follow the path of service, and may God bless their memories. Amen.

MEMORIAL ADDRESS BY RANDY CHRISTMANN, PUBLIC SERVICE COMMISSIONER and FORMER SENATOR

Today I stand here with my mind flooded with memories. Memories of my first nervous days sitting there in Seat #41 in my first session in 1995. Memories of sitting there before the Memorial Service and discussing with my seat mate, Senator Wanzek, the fact that at some time in the future our names would be in the Memorial brochure.

I have memories of how I used to like to come in here in the evenings to work on legislation or on constituent responses and would often find myself lost in thought about how it must have felt to serve during the Depression or during the depths of World War II. Those Senators knowing they had to concentrate on the tasks at hand, even tho, with the fate of the free world in question, the work of the State also needed to be done.

I have memories of the difficult final days of nine legislative sessions, six of them spent in seat #34 between Senators Stenehjem and Klein. I have memories of bills we worked on, failures, successes, regrets, and proud moments. And I stand here wondering what types of memories are running through each of your minds.

But, at most times in my day to day life, when I think of the Senate, and that's a lot, I don't think of the work that we did, I think of the people. Some people who would surprise me on those rare times when we voted differently on bills. Others who surprised me just as much when we voted the same. Some people I only got to know for a short time. Others were here through most of the same years that I was honored to serve. Even people that were not actually elected, but were families of fellow Senators, and the wonderful people who have been with us as employees, lobbyists, frequent activists, and the press.

Just two weeks ago my wife Bethanie and I attended a funeral viewing for a young man whose parents are long-time friends, and whose mother is actually one of those wonderful Senate employees of days gone by. We talked to family, but while talking to other unrelated

friends, I looked around the room and observed the extra closeness of those who were actually family. Family is truly a special attachment that surpasses the bonds of friendship and of most work relationships.

I think that the reason that, in day to day life, my memories of the Senate are more about the people than the work is because, unlike most typical work environments, the Senate somehow makes us family. It makes us family with special attachments like genetic family members share. The Senate has given us those special bonds that mean when people pass, even people we have never met, we feel a closeness that surpasses the closeness of most work relationships and is much more familial.

Looking at the list of Senators who we are here to honor today, I can't help but feel that family bond. Like a family tree, there are so many interesting puzzle pieces to put together. The Senate careers of these individuals span five and one-half decades, but they were all born within an 11-year period. They grew up or entered adulthood during the worst of times, the Depression and World War II. Maybe that was partially what instilled the work ethic and decency that I admire so much.

Two of the eight I served with, six of them I had the opportunity to meet, although I feel I personally really knew just four. But just like a distant relative I've not personally met, to me they are all family and I find myself wondering, imagining, and wishing I knew more about each and that I had more time to spend with each.

To make up for lack of personal knowledge I've done some research, and it can be summarized by words from the song you just heard: "After all our hopes and dreams have come and gone, and our children sift thru all we've left behind, may the clues that they discover and the memories they uncover, become the light that leads them to the road we each much must find." While some served later in life, and some served earlier in life, these eight Senators had amazing careers both within and outside the Senate. But even more special than their careers are their amazing families.

Sen. Murphy, who previously worked at the PSC, began his service in this Chamber during the Eisenhower Administration, before I and 12 of our sitting Senators were even born! He served the Mandan area, although I do not know whether he referred to it as "Bismarck's western upper-class suburb" as Sen. Cook now does. In 1960 he was his party's nominee for Attorney General. He was also very frustrated about problems at the YCC, which he believed needed a Governor's investigation. When he felt ignored, he interrupted a statewide radio broadcast of the Governor of his own party and cornered him about the problem. He did so knowing the move would cost him the support of his party and any opportunity for success in November, but he did what he thought was right, not what he thought was popular. It may have cost him the Attorney General's seat, but he ultimately received a Presidential appointment to serve the FDIC and had a distinguished career.

Sen. Meschke ultimately became a North Dakota Supreme Court Justice. He was a cowboy who was raised in the badlands, but was stricken with rheumatoid arthritis during early adulthood that caused him to be stooped over and in pain for most of his life. Some referred to him as a great mind with a broken body. But he would not allow his malady to become debilitating. One of my all-time favorite attorneys of our own generation practices at the same firm in Minot where Sen. Meschke practiced, before he became a Justice, and again after he retired. That attorney once wrote, "...there is a community of his admirers who knew him as (a) kind, compassionate man, who went out of his way to listen to, and help the less fortunate. Perhaps his body was broken. But his heart was every bit as impressive as his legal mind." That was very well-said Sen. Hogue.

Sen. Sinner took a hiatus and eventually returned to serve as Governor. His term as Governor preceded my time in the Senate, and I certainly did not agree with all of his policies, but we should never forget his time as Governor included extraordinarily difficult times. The farm crisis was a national phenomenon, and it was an enormous challenge for North Dakota. The deployment of our National Guard soldiers during Operation Desert Storm was a tumultuous learning experience as we began this new era of dangerous overseas deployments that have become the reality of the last few decades. But through it all he stayed true to his principals, and led the phenomenal North Dakota Centennial Celebration, where, despite difficult times, North Dakotans were inspired to keep moving forward. Amazingly, despite a scolding from his own Highway Patrol Commander where he was told to "use a little sense," he showed his strong personal compassion by helping hitchhikers he encountered, even while serving as Governor.

Senators Farrington and Andrist, ironically, were both distinguished leaders in the field of journalism and publishing. Sen. Andrist even lead the National Newspaper Association. Imagine the stories those two shared a few decades ago.

I never met Sen. Farrington, but his brother and family lived in Hazen, so I pretty much grew up with 5 Farrington kids and we had a lot of fun. That connection causes me to know that his work in journalism, in his community, and in the Senate caused him to be a leading contender for the nomination for Governor in 1980. But the health issues of a family member were a priority, so he set aside his dreams and ambitions to seek a warmer climate for her. There he worked as a public information officer for FEMA over the years at 20 disaster sites in multiple states, Puerto Rico, and American Samoa.

The other journalist in the bunch was Sen. Andrist, and it was my huge honor to serve my entire 18 years in the Senate alongside this titan of honesty, decency, and compassion. He always approached policy making from a sense of mutual respect and love, and often with a glimmer in his eye. On one occasion, after fainting in the IBL committee meeting because of low blood pressure, he came to and said the last thing he remembered was hearing Sen. Tracy Potter agree with him. He frequently reminded us that humor is a gift from above. John and Elaine were inseparable until God took her home, and those two taught me a great deal about the importance of our service, and how to be effective in rural districts like he and I served.

Sen. Iszler served a distinguished career here in the Senate, and ultimately allowed his ranch to become North Dakota's very important Central Grasslands Research Extension Center. Many of you remember his beautiful wife Peggy who worked the kiosk for us for a number of years. Well, Sen. Iszler would come by to visit her and I cannot count the hours of his time that I and a few others around here stole to try to learn from his experience and wisdom. Never once did he push for a certain outcome, but when asked, he was always willing to give of his time and intelligence to try to help people reach a good solution. No recognition or compensation required. That would not have been Sen. Iszler's way.

Sen. Langley will never be forgotten for his "ranchy" ways, whether he was in his pastures near Warwick or on the floor of the Senate. He was not known to worry much about the phone messages placed on his desk spindle every day before we had email, and he was not at all delicate when letting you know what he thought. But those who knew him knew that he used his unique style to achieve the results he was seeking. His support of the ND Cowboy Hall of Fame, his support of the National Guard, and his role in creating the Water Development Trust Fund are just a few examples of the impact he had on North Dakota. That impact was recognized when he was elected President Pro Tempore of the Senate in 1993.

Sen. Albers was one of my predecessors from District 33. He was an entrepreneurial ag producer, served later in life on the County Commission, but was, I think, may be best known for his work helping build the great, award-winning coal reclamation program we have in North Dakota to this day. But what you don't know is that in the 1970's my own family went through a very difficult time, victimized by poorly written eminent domain law. It was certainly not anything that would ever impact large numbers of voters, and the solution was not something that would draw accolades to the Senator who did the heavy lifting to amend the law. But Sen. Albers went to work, and even though it was too late to remedy the problem for us, he did his best to prevent similar inequities from happening to others. My parents were agrarian people, unaccustomed to this type of an environment. They were forever grateful that their Senator helped prepare them to testify and worked so hard to help others. He didn't know it then, but he also reinforced my belief in the meaningfulness of public service.

Eight great men. Eight unique, shining examples of how North Dakota Senators make North Dakota and America greater, one small step at a time. This is public service, and this is the side of public service that most of the public does not get to see, but family sees it. This is the side of public service that most of the public does not understand but it draws us together in such a unique way and makes us ... family.

Only family really understands what other family members go through. We get it. Today, I know that the Senators of the 66th Legislative Assembly are grateful beyond words for Senate family members from years gone by who have come today, so that even all these years later we can express our appreciation. And to those of you still serving, I leave you

with a few more words from the song we heard earlier, "... as those who've gone before us, let us leave to those behind us, the heritage of faithfulness, passed on thru Godly lives."
