6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the public service commission for the purpose of defraying the expenses of the public service commission, for the biennium beginning July 1, 2019, and ending June 30, 2021, as follows:

16	SECTION 3. TRANSFER AND REPAYMENT - BEGINNING FARMER REVOLVING LOAN				
17	FUND. The Bank of North Dakota shall transfer from the beginning farmer revolving loan fund to				
18	the public service commission the sum of \$900,000, or so much of the sum as may be				
19	necessary, included in the estimated income line item in section 1 of this Act to pay for costs				
20	associated with a rail rate complaint case. Transfers must be made during the biennium				
21	beginning July 1, 2019, and ending June 30, 2021, upon order of the commission. If any				
22	amounts are spent pursuant to this section, the public service commission shall reimburse the				
23	beginning farmer revolving loan fund using amounts available from damages or proceeds				
24	received, net of legal fees, from a successful outcome of a rail complaint case.				
25	SECTION 4. AMENDMENT. Section 49-01-05 of the North Dakota Century Code is				
26	amended and reenacted as follows:				
27	49-01-05. Salary of commission	ners.			
28	The annual salary of a commissioner is one hundred fiveten thousand four eight hundred				
29	ninety-onetwenty-nine dollars through June 30, 20162020, and one hundred eightfourteen				
30	thousand sixone hundred fifty-sixfifty-four dollars thereafter. All fees received or charged by any				
31	commissioner for any act or service rendered in any official capacity must be accounted for and				

- 1 paid over by the commissioner monthly to the state treasurer and must be credited to the 2 general fund of the state. 3 **SECTION 5. AMENDMENT.** Section 57-43.2-19 of the North Dakota Century Code is 4 amended and reenacted as follows: 5 57-43.2-19. Transfer, deposit, and distribution of funds. (Effective July 1, 2015, 6 through June 30, 2019) 7 All taxes, license fees, penalties, and interest collected under this chapter must be 8 transferred to the state treasurer who shall deposit moneys in a highway tax distribution fund, 9 except all special fuels excise taxes collected on sales of diesel fuel to a railroad under section 10 57-43.2-03 of up to two hundred eighty-fiveninety-four thousand six hundred fifty-five dollars per 11 year must be transferred to the state treasurer who shall deposit the moneys in the rail safety 12 fund. The highway tax distribution fund must be distributed in the manner as prescribed by 13 section 54-27-19.
- 14 Transfer, deposit, and distribution of funds. (Effective after June 30, 2019) All taxes,
 15 license fees, penalties, and interest collected under this chapter must be transferred to the state
 16 treasurer who shall deposit moneys in the highway tax distribution fund. The highway tax
 17 distribution fund must be distributed in the manner as prescribed by section 54-27-19.
