Organizations that qualify and conduct calcuttas would no longer have to apply for a state gaming license. These organizations can obtain a local permit and will no longer pay state gaming taxes. The gross proceeds from the current licensed organizations is \$600,000 per biennium resulting in \$6,000 per biennium in gaming taxes.
