- 1 A BILL for an Act to create and enact two new sections to chapter 50-06 of the North Dakota
- 2 Century Code, relating to the assessment of individuals with an intellectual disability; and to
- 3 amend and reenact sections 25-04-02.1 and 25-16-01 of the North Dakota Century Code,
- 4 relating to the licensure of life skills and transition center by the department of human services;
- 5 and to provide for a legislative management study.

6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Section 25-04-02.1 of the North Dakota Century Code is
 amended and reenacted as follows:
- 9 25-04-02.1. Accreditation of life skills and transition center Licensure.
- 1. The department of human services shall request appropriations and resources

 11 sufficient to ensure maintenance of the life skills and transition center's accreditation

 12 by the accreditation council on services for people with developmental disabilities and

 13 certification by the health care financing administration orand, if deemed necessary, by

 14 similar accrediting and certifying organizations and agencies possessing standards

 15 applicable to an individual with a developmental disability and disciplines needed to

 16 provide quality services to individuals served.
 - Upon a showing the life skills and transition center satisfies the requirements of licensure, the department of human services shall issue a license as required under section 25-16-03.
- 20 **SECTION 2. AMENDMENT.** Section 25-16-01 of the North Dakota Century Code is 21 amended and reenacted as follows:

- In this chapter unless the context or subject matter otherwise requires:
 - "Department" means the department of human services.

1	2.	"Treatment or care center" means an entity providing services to individuals with
2		developmental disabilities and licensed by the department to provide services. The
3		term includes the life skills and transition center.
4	SECTION 3. A new section to chapter 50-06 of the North Dakota Century Code is created	
5	and enacted as follows:	
6	Assessment of individuals with an intellectual disability.	
7	The department shall establish and implement a standardized assessment tool such as the	
8	American association on intellectual and developmental disabilities' supports intensity scale to	
9	assess individuals with an intellectual disability who are served through the department,	
10	including	the life skills and transition center and the state hospital.
11	SECTION 4. A new section to chapter 50-06 of the North Dakota Century Code is created	
12	and enacted as follows:	
13	Regional crisis support services for individuals with an intellectual disability.	
14	The o	department shall establish regional crisis support services for individuals with an
15	intellectu	al disability. Each regional crisis support services local team must include at least two
16	individua	ls with available contracted support. The regional crisis support services teams shall
17	provide ti	imely one-on-one crisis assistance to individuals with an intellectual disability.
18	SEC	TION 5. LEGISLATIVE MANAGEMENT STUDY - ASSESSMENT OF INDIVIDUALS
19	WITH AN	INTELLECTUAL DISABILITY. During the 2019-20 interim, the legislative
20	manager	ment shall consider studying the results of the standardized assessment of individuals
21	with an ir	ntellectual disability. The study must consider which services, support, and funding are
22	necessar	ry to allow individuals with an intellectual disability to live in and remain in their
23	communi	ity. The legislative management shall report its findings and recommendations, together
24	with any legislation necessary to implement the recommendations, to the sixty-seventh	
25	legislativ	e assembly.
