- 1 A BILL for an Act to create and enact chapter 51-37 of the North Dakota Century Code, relating-
- 2 to protection against the disclosure of personal information; and to provide a penalty.for an Act
- 3 to provide for a legislative management study of consumer personal data disclosures.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1.** Chapter 51-37 of the North Dakota Century Code is created and enacted as 6 follows: 7 51-37-01. Definitions. 8 For purposes of this chapter: 9 "Covered entity" means a partnership, limited liability company, corporation, or other 10 legal entity that collects consumers' personal information, does business in the state, 11 and: 12 Has annual gross revenues in excess of twenty-five million dollars; 13 Annually buys, receives, sells, or shares personal information of at least fifty 14 thousand consumers, households, or devices; or 15 Derives at least fifty percent of its annual revenues from selling personal 16 information. 17 "Personal information" means information that identifies, describes, or could 18 reasonably be linked with a particular individual. The term does not include publicly 19 available information lawfully made available to the general public from federal, state, 20 or local government records. The term includes: 21 Personal identifiers including real name, alias, postal address, unique personal 22 identifier, online identifier internet protocol address, electronic mail address, 23 account name, social security number, date of birth, operator's license number, 24 passport number, or other similar identifier.

3	51-37-03. Accounting of personal information.
4	1. Within forty-five days after receiving a request from an individual, a covered entity
5	shall disclose to the individual the categories and specific pieces of personal
6	information the covered entity possesses regarding the individual or the individual's
7	minor child.
8	2. To ensure the covered entity discloses the requested personal information to the
9	appropriate individual, a covered entity shall implement appropriate processes and
10	safeguards for verifying an individual's request under subsection 1.
11	51-37-04. Enforcement - Powers - Remedies - Penalties.
12	If an individual has reasonable cause to believe the personal information of the individual or
13	the individual's minor child is purchased, received, sold, or shared by a covered entity in
14	violation of this chapter, the individual may submit a complaint to the attorney general. To
15	enforce this chapter, the attorney general may:
16	1. Seek and obtain in an action in a district court an injunction prohibiting the covered
17	entity from continuing the unlawful practice, engaging in the unlawful practice, or doing
18	any act in furtherance of the unlawful practice after appropriate notice to the covered
19	entity. The notice must state generally the relief sought and be served at least ten
20	days before the hearing of the action. The court may make an order or judgment as
21	may be necessary to prevent the use or employment by a covered entity of any
22	unlawful practices.
23	2. Issue a cease and desist order, without notice and hearing, which the attorney general
24	deems necessary or appropriate in the public interest.
25	3. Impose by order and collect a civil penalty against a covered entity found in an
26	adjudicative proceeding to have violated a cease and desist order issued under this
27	section, in an amount not less than one hundred thousand dollars and not more than
28	two hundred fifty thousand dollars for each violation.
29	4. Bring an action in district court to recover penalties under this section.
30	5. A covered entity aggrieved by an order issued under this section may request a
31	hearing before the attorney general if a written request is made within ten days after

the receipt of the order. An adjudicative proceeding under this section must be conducted in accordance with chapter 28-32, unless otherwise specifically provided herein. If the attorney general prevails in an adjudicative proceeding under this section, the attorney general may assess the nonprevailing covered entity for alladjudicative proceeding and hearing costs, including reasonable attorney's fees, investigation fees, costs, and expenses of any investigation and action.

If an individual's personal information is purchased, received, sold, or shared by a covered entity in violation of this chapter, the individual may bring a civil action in a court of this state with jurisdiction over the covered entity to recover damages, costs, and fees, including reasonable attorney's fees; or obtain injunctive or declaratory relief; or any other relief the court deems proper.

SECTION 1. LEGISLATIVE MANAGEMENT STUDY - CONSUMER PERSONAL DATA DISCLOSURES. During the 2019-20 interim, the legislative management shall study protections, enforcement, and remedies regarding the disclosure of consumers' personal data. The study must include a review of privacy laws of other states and applicable federal law. The legislative management shall report its findings and recommendations, together with any legislation required to implement the recommendations, to the sixty-seventh legislative assembly.
