- 1 A BILL for an Act to create and enact two new sections to chapter 15.1-19 of the North Dakota
- 2 Century Code, relating to the prohibition on aiding and abetting sexual abuse; and to provide for
- 3 a penalty.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. A new section to chapter 15.1-19 of the North Dakota Century Code is created
6 and enacted as follows:

7 Prohibition on aiding and abetting sexual abuse.

- 8 <u>1.</u> The state educational agency, or local educational agency that receives federal funds.
 9 under section 8546 of the Elementary and Secondary Education Act [20 U.S.C. 7926].
- 10 <u>shall prohibit any individual who is a school employee, contractor, or agent, or any</u>
- 11 <u>state educational agency or local educational agency, from assisting a school</u>
- 12 <u>employee, contractor, or agent in obtaining a new job, apart from the routine</u>
- 13 transmission of administrative and personnel files, if the individual or agency knows, or
- 14 has substantial probable cause to believe, that the school employee, contractor, or
- 15 agent engaged in sexual misconduct regarding a minor or student in violation of law.
- 16 <u>2.</u> <u>Subsection 1 does not apply if:</u>
- 17 a. The information giving rise to probable cause has been properly reported to a law
 18 enforcement agency with jurisdiction over the alleged misconduct and any other
 19 authorities as required by federal, state, or local law; and

 b. (1)
 The matter has been officially closed or the prosecutor or police with

 jurisdiction over the alleged misconduct has investigated the allegations and

 notified school officials that there is insufficient information to establish

 probable cause that the school employee, contractor, or agent engaged in
- 24 sexual misconduct regarding a minor or student in violation of the law;

1	<u>(2)</u>	The school employee, contractor, or agent has been charged with, and
2		acquitted or otherwise exonerated of the alleged misconduct; or
3	<u>(3)</u>	The case or investigation remains open and there have been no charges
4	I	filed against, or indictment of, the school employee, contractor, or agent
5		within four years one year of the date on which the information was reported
6		to a law enforcement agency.
7	SECTION 2. A new section to chapter 15.1-19 of the North Dakota Century Code is created	
8	and enacted as follows:	
9	Conviction of aiding and abetting sexual abuse - Penalty.	
10	Any individual who is a school district employee, contractor, or agent convicted of aiding	
11	and abetting sexual abuse as described in section 1 of this Act is guilty of a class B	
12	misdemeanor.
