## **HOUSE BILL NO. 1110**

1	A BILL for an Act to create and enact section 44-06.1-13.1 and a new section to chapter 44-06.1
2	of the North Dakota Century Code, relating to the adoption of the Revised Uniform Law on
3	Notarial Acts; and to amend and reenact sections 11-18-15, 44-06.1-01, 44-06.1-03, and
4	44-06.1-18, and 47-19-26 of the North Dakota Century Code, relating to the adoption of the
5	Revised Uniform Law on Notarial Acts.

## 6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 11-18-15 of the North Dakota Century Code is
 amended and reenacted as follows:
 11-18-15. Notary seal on documents filed with recorder - Stamp or imprint allowed.

The notary seal on any document filed with a recorder may be in:

- 1. In either a stamped or an imprinted form; or
- 2. An official stamp, as defined in section 44-06.1-01.

**SECTION 2. AMENDMENT.** Section 44-06.1-01 of the North Dakota Century Code is amended and reenacted as follows:

## 44-06.1-01. Definitions.

- "Acknowledgment" means a declaration by an individual before a notarial officer that
  the individual has signed a record for the purpose stated in the record and, if the
  record is signed in a representative capacity, that the individual signed the record with
  proper authority and signed it as the act of the individual or person identified in the
  record.
- 2. "Electronic" means relating to technology having electrical, digital, magnetic, wireless, optical, electromagnetic, or similar capabilities.

- "Electronic signature" means an electronic symbol, sound, or process attached to or
   logically associated with a record and executed or adopted by an individual with the
   intent to sign the record.
- 4. "In a representative capacity" means acting as:
  - a. An authorized officer, agent, partner, trustee, or other representative for a person other than an individual;
    - b. A public officer, personal representative, guardian, or other representative, in the capacity stated in a record;
    - c. An agent or attorney in fact for a principal; or
  - d. An authorized representative of another in any other capacity.
- 15. "Notarial act" means an act, whether performed with respect to a tangible or electronic 12 record, that a notarial officer may perform under the law of this state. The term 13 includes taking an acknowledgment, administering an oath or affirmation, taking a 14 verification on oath or affirmation, witnessing or attesting a signature, certifying or 15 attesting a copy except as provided in subsection 7 of section 44-06.1-23, and noting 16 a protest of a negotiable instrument.
- 17 6. "Notarial officer" means a notary public or other individual authorized to perform a notarial act.
- 7. "Notary public" means an individual commissioned to perform a notarial act by the secretary of state.
- 21 8. "Official stamp" means a physical image affixed to a tangible record or an electronic image attached to or logically associated with an electronic record.
- 9. "Person" means an individual, corporation, business trust, statutory trust, estate, trust,
  partnership, limited liability company, association, joint venture, public corporation,
  government or governmental subdivision, agency, or instrumentality, or any other legal
  or commercial entity.
- 27 <u>10.</u> "Record" means information that is inscribed on a tangible medium or that is stored in an electronic or other medium and is retrievable in perceivable form.

  - a. To execute or adopt a tangible symbol; or

6	<u>4.</u>	If a notarial act is performed under this section, the certificate of notarial act required
7		by section 44-06.1-14 and the short-form certificate provided in section 44-06.1-19
8		must indicate the notarial act was performed using communication technology.
9	<u>5.</u>	A short-form certificate provided in section 44-06.1-19 for a notarial act subject to this
0		section is sufficient if it:
11		a. Complies with the rules adopted under subdivision a of subsection 8; or
2		b. Is in the form provided in section 44-06.1-19 and contains a statement
3		substantially as follows: "This notarial act involved the use of communication
4		technology."
5	<u>6.</u>	A notary public, a guardian, conservator, or agent of a notary public, or a personal
6		representative of a deceased notary public shall retain the audiovisual recording
7		created under subdivision c of subsection 3 or cause the recording to be retained by a
8		repository designated by or on behalf of the person required to retain the recording.
9		Unless a different period is required by rule adopted under subdivision d of
20		subsection 8, the recording must be retained for a period of at least ten years after the
21		recording is made.
22	<u>7.</u>	Before a notary public performs the notary public's initial notarial act under this
23		section, the notary public must notify the secretary of state that the notary public will
24		be performing notarial acts with respect to remotely located individuals and identify the
25		technologies the notary public intends to use. If the secretary of state has established
26		standards under subsection 8 and section 44-06.1-25 for approval of communication
27		technology or identity proofing, the communication technology and identity proofing
28		must conform to the standards.
29	<u>8.</u>	In addition to adopting rules under section 44-06.1-25, the secretary of state may
30		adopt rules under this section regarding performance of a notarial act. The rules may

1 Prescribe the means of performing a notarial act involving a remotely located 2 individual using communication technology; 3 <u>b.</u> Establish standards for communication technology and identity proofing; 4 Establish requirements or procedures to approve providers of communication <u>C.</u> 5 technology and the process of identity proofing; and 6 <u>d.</u> Establish standards and a period for the retention of an audiovisual recording 7 created under subdivision c of subsection 3. 8 <u>9.</u> Before adopting, amending, or repealing a rule governing performance of a notarial act 9 with respect to a remotely located individual, the secretary of state shall consider: 10 The most recent standards regarding the performance of a notarial act with a. 11 respect to a remotely located individual promulgated by national standard-setting 12 organizations and the recommendations of the national association of secretaries 13 of state; 14 Standards, practices, and customs of other jurisdictions that have laws <u>b.</u> 15 substantially similar to this section; and 16 The views of governmental officials and entities and other interested persons. 17 <u>10.</u> By allowing its communication technology or identity proofing to facilitate a notarial act 18 for a remotely located individual or by providing storage of the audiovisual recording 19 created under subdivision c of subsection 3, the provider of the communication 20 technology, identity proofing, or storage appoints the secretary of state as the 21 provider's agent for service of process in any civil action in this state related to the 22 notarial act. 23 **SECTION 5. AMENDMENT.** Section 44-06.1-18 of the North Dakota Century Code is 24 amended and reenacted as follows: 25 44-06.1-18. Notification regarding performance of notarial acts on electronic record -26 Selection of technology - Acceptance of tangible copy of electronic record. 27 A notary public may select one or more tamper-evident technologies to perform 28 notarial acts with respect to electronic records. An individual may not require a notary 29 public to perform a notarial act with respect to an electronic record with a technology 30 that the notary public has not selected.

1 Before a notary public performs the notary public's initial notarial act with respect to an 2 electronic record, a notary public shall notify the secretary of state that the notary 3 public will be performing notarial acts with respect to electronic records and identify 4 the technology the notary public intends to use. If the secretary of state has 5 established standards for approval of technology pursuant to section 44-06.1-25, the 6 technology must conform to the standards. If the technology conforms to the 7 standards, the secretary of state shall approve the use of the technology. 8 A recorder may shall accept for recording a tangible copy of an electronic record 9 containing a notarial certificate as satisfying any requirement that a record accepted 10 for recording be an original, if the notarial officer executing the notarial certificate 11 certifies the tangible copy is an accurate copy of the electronic record. 12 SECTION 6. A new section to chapter 44-06.1 of the North Dakota Century Code is created 13 and enacted as follows: 14 Journals. 15 A notary public shall maintain a journal in which the notary public chronicles all notarial 16 acts the notary public performs with respect to a remotely located individual under 17 section 44-06.1-13.1. The notary public shall retain the journal for ten years after the 18 performance of the last notarial act chronicled in the journal. 19 A journal may be created on a tangible medium or in an electronic format. A notary 20 public shall maintain only one journal at a time to chronicle all notarial acts performed 21 regarding tangible records and one or more journals to chronicle all notarial acts 22 performed regarding electronic records. If a journal is maintained on a tangible 23 medium, it must be a permanent, bound register with numbered pages. If the journal is 24 maintained in an electronic format, it must be in a permanent, tamper-evident 25 electronic format complying with the rules of the secretary of state. 26 An entry in a journal must be made contemporaneously with performance of the 27 notarial act and contain the following information: 28 The date and time of the notarial act; 29 A description of the record, if any, and type of notarial act; 30 The full name and address of each individual for whom the notarial act is

1		d. If identity of the individual is based on personal knowledge, a statement to that
2		effect;
3		e. If identity of the individual is based on satisfactory evidence, a brief description of
4		the method of identification and the identification credential presented, if any,
5		including the date of issuance and expiration of the identification credential; and
6		f. The fee, if any, charged by the notary public.
7	4.	If the journal of a notary public is lost, the notary public loses access to the journal, or
8		the journal is stolen, the notary public promptly shall notify the secretary of state upon
9		discovering the journal is lost, access is lost, or the journal is stolen.
10	<u>5.</u>	On resignation from, or the revocation or suspension of, the commission of a notary
11		public, the notary public shall retain the journal in accordance with subsection 1 of this
12		section and inform the secretary of state where the journal is located.
13	6.	Instead of retaining a journal as provided in subsections 1 and 5, a current or former
14		notary public may transmit the journal to a repository approved by the secretary of
15		state.
16	<u>7.</u>	Upon the death or adjudication of incompetency of a current or former notary public,
17		the personal representative or guardian of the notary public shall retain the journal as
18		provided in subsections 1 and 5 or transmit the journal to a repository approved by the
19		secretary of state.
20	SEC	TION 7. AMENDMENT. Section 47-19-26 of the North Dakota Century Code is
21	amende	d and reenacted as follows:
