- 1 A BILL for an Act to amend and reenact sections 23-01-44 and 50-06-01 of the North Dakota
- 2 Century Code, relating to duties of the department of human services behavioral health division.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 SECTION 1. AMENDMENT. Section 23-01-44 of the North Dakota Century Code is

5 amended and reenacted as follows:

## 6 **23-01-44. Syringe or needle exchange program - Authorization.**

8 a. "Program" means a syringe exchange program <u>established and</u> operated under
9 this section.

## 10 b. "Qualified entity" means:

- (1) A local health department;
- (2) A city that operates a program within the boundaries of the city; or
- 13 (3) An organization that has been authorized to operate a program by the state
  14 department of health, the board of county commissioners, or the governing
  15 body for the operation of a program within the boundaries of the city.
- 16 2. <u>The state department of health, in collaboration with the department of human</u>
- services behavioral health division, shall design a syringe exchange program. The
   state department of health shall administer the program.
- 193.The state department of health may authorize a qualified entity to operate a program20in a county if:
- a. The area to be served is at risk of an increase or potential increase in prevalence
  of viral hepatitis or human immunodeficiency virus;
- b. A syringe exchange program is medically appropriate as part of a comprehensive
  public health response; and
