4	BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:					
5	SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds					
6	as may be necessary, are appropriated out of any moneys in the general fund in the state					
7	treasury, not otherwise appropriated, and from special funds derived from the insurance					
8	regulatory trust fund, not otherwise appropriated, to the legislative branch of state government					
9	for the purpose of defraying the expenses of the legislative branch of state government, for the					
10	fiscal period beginning with the effective date of this Act and ending June 30, 2021, as follows:

SECTION 2. TRANSFERS. Notwithstanding section 54-16-05, the director of the office of management and budget shall transfer appropriation authority between line items of the legislative management and legislative council as may be requested by the chairman of the legislative management or the director of the legislative council upon the finding by the chairman or the director that the nature of studies and duties assigned to the legislative management or legislative council requires the transfers in properly carrying on the legislative management's and legislative council's functions and duties. The director of the office of management and budget shall similarly make transfers of appropriation authority between the line items for the sixty-sixth and sixty-seventh legislative assemblies, upon request by the chairman of the legislative management or the director of the legislative council upon the finding by the chairman or director that the transfers are required for the legislative assembly to carry on its functions and duties.

SECTION 3. APPLICATION, TRANSFER AUTHORITY, AND CANCELLATION OF UNEXPENDED APPROPRIATIONS. Sections 54-16-04 and 54-44.1-11 do not apply to chapter 26 of the 2017 Session Laws. The director of the office of management and budget shall make transfers of appropriation authority between the line items and the agencies of the legislative branch within section 1 of that chapter as requested by the chairman of the legislative management or the director of the legislative council. - 1 shall cancel unexpended appropriations for the legislative assembly and legislative council
- 2 enacted prior to the 2017-19 biennium as directed by the chairman of the legislative
- 3 management or the director of the legislative council.
- 4 **SECTION 4. EMERGENCY.** This Act is declared to be an emergency measure.
