## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1. AMENDMENT.** Section 12.1-01-05 of the North Dakota Century Code is amended and reenacted as follows:
- 7 12.1-01-05. Crimes defined by state law shallmay not be superseded by city or county 8 ordinance or by home rule city's or county's charter or ordinance.
  - No Except as provided in section 40-05-06, an offense defined in this title or elsewhere by law shallmay not be superseded by any city or county ordinance, or city or county home rule charter, or by an ordinance adopted pursuant to such a charter, and all such offense definitions shall have full force and effect within the territorial limits and other jurisdiction of home rule cities or counties. This section shalldoes not preclude any city or county from enacting any ordinance containing penal language when otherwise authorized to do so by law.
- SECTION 2. AMENDMENT. Section 39-06.1-06 of the North Dakota Century Code is amended and reenacted as follows:
- 17 **39-06.1-06.** Amount of statutory fees.
- The fees required for a noncriminal disposition under section 39-06.1-02 or 39-06.1-03 must be as follows:
  - For a nonmoving violation as defined in section 39-06.1-08, a fee of twentyforty dollars
    except for a violation of any traffic parking regulation on any state charitable or penal
    institution property or on the state capitol grounds, a fee in the amount of fiveten
    dollars, excluding a violation of subsection 11 of section 39-01-15.

For a violation of section 39-21-44 or a rule adopted under that section, a fee of two 24 hundred fifty dollars. 25 Except as provided in subsections 5 and 7, for a violation of section 39-09-02, or an 26 equivalent ordinance, a fee established as follows: 27 Miles per hour over 28 lawful speed limit Fee 29 1 - 5 \$ <del>5</del>10 30 6 - 10 \$ 510 plus \$1/each mph over 5 mph over limit 31 11 - 15 \$ 1015 plus \$1/each mph over 10 mph over limit

- 6. For a violation of subsection 3 of section 39-21-46, a fee established as follows:
  - a. Driving more than eleven hours since the last ten hours off duty, driving after fourteen hours on duty since the last ten hours off duty, driving after sixty hours on duty in seven days or seventy hours in eight days, no record of duty status or log book in possession, failing to retain previous seven-day record of duty status or log book, or operating a vehicle with four to six out-of-service defects, one hundred dollars:
  - False record of duty status or log book or operating a vehicle with seven to nine out-of-service defects, two hundred fifty dollars;
  - c. Operating a vehicle after driver placed out of service, operating a vehicle with ten or more out-of-service defects, or operating a vehicle that has been placed out of service prior to its repair, five hundred dollars; and
  - All other violations of motor carrier safety rules adopted under subsection 3 of section 39-21-46, fifty dollars.
  - 7. On a highway on which the speed limit is posted in excess of sixty-five miles [104.61 kilometers] an hour, for a violation of section 39-09-02, or equivalent ordinance, a fee of <u>fiveten</u> dollars for each mile per hour over the limit.
  - 8. For a violation of a school zone speed limit under subdivision b of subsection 1 of section 39-09-02, a fee of fortyone hundred dollars for one through ten miles per hour

- over the posted speed; and fortyone hundred dollars, plus one dollar two dollars for each additional mile per hour over ten miles per hour over the limit unless a greater fee would be applicable under this section.
  - 9. For a violation of a highway construction zone speed limit under subsection 2 of section 39-09-02, a fee of eightyone hundred dollars for one through ten miles per hour over the posted speed; and eightyone hundred dollars plus twofour dollars for each mile per hour over ten miles per hour over the limit, unless a greater fee would be applicable under this section. The fee in this subsection does not apply to a highway construction zone unless individuals engaged in construction are present at the time and place of the violation and the posted speed limit sign states "Minimum Fee \$80\$100".
