Amend Section 4.1-21-04 of the North Dakota Century Code to increase the maximum fund balance limit in the State Forester Reserve Account from \$1,000,000 to \$2,000,000. The new maximum would ensure adequate funds are available for emergencies at the state nursery including seedling crop losses.

- B. **Fiscal impact sections:** *Identify and provide a brief description of the sections of the measure which have fiscal impact. Include any assumptions and comments relevant to the analysis.*

The proposed legislation would amend Section 4.1-21-04 of the North Dakota Century Code to increase the maximum fund balance limit in the State Forester Reserve Account from \$1,000,000 to \$2,000,000. In addition, the minimum fund balance limit would be raised from \$700,000 to \$1,700,000 to more realistically reflect the current cost of tree production at Towner State Nursery. The new maximum would ensure adequate funds are available for emergencies at the state nursery including seedling crop losses. Revenues for the reserve fund are derived from the sale of seedlings. The State Forester has authority to change 110% the cost of production and extra revenues that exceed the cost of production must be deposited into the reserve account. No fiscal impacts are anticipated as revenues for the reserve fund are derived from the sale of nursery stock.

Revenues for the reserve fund are derived from the sale of nursery stock. The agency anticipates approximately \$80,000 in revenue in excess of the cost of production that will be required to be deposited into the reserve fund for each of the next 3 biennia.

The agency does not anticipate any expenditures from the reserve fund.
