Changes the responsibility for payment of witness fees and other expenses incurred by fact witnesses subpoenaed by indigent defense attorneys, in proceedings under NDCC Chapter 27-20 (the uniform juvenile court act) from the Attorney General to the Commission.

Currently, the attorney general is responsible for paying the witness fees, mileage, and travel expenses incurred by fact witnesses in proceedings under Chapter 27-10 of the NDCC (the uniform juvenile court act). This bill would change that as to fact witnesses subpoenaed for juvenile court proceedings by indigent defense attorneys (attorneys employed by or contracted with the Commission to provide indigent defense services in such cases). In cases in which the Commission provides indigent defense services, the Commission, rather than the Attorney General, would pay the witness fees and expenses for the witnesses subpoenaed by counsel employed by or contracted with the Commission.
