

**FIRST ENGROSSMENT  
with Conference Committee Amendments  
ENGROSSED SENATE BILL NO. 2006**

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the North Dakota  
2 aeronautics commission; and to provide an exemption.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to the North Dakota aeronautics commission for the purpose of defraying the  
8 expenses of the North Dakota aeronautics commission, for the biennium beginning July 1,  
9 2021, and ending June 30, 2023, as follows:

19 **SECTION 2. ONE-TIME FUNDING.** The following amounts reflect the one-time funding  
20 items approved by the sixty-sixth legislative assembly for the 2019-21 biennium:

1       **SECTION 3. ESTIMATED INCOME - AIRPORT INFRASTRUCTURE FUND - AIRPORT**

2       **GRANTS - EXEMPTION.** The estimated income line item in section 1 of this Act includes  
3       \$20,000,000 from the airport infrastructure fund for the aeronautics commission to provide  
4       grants to airports during the biennium beginning July 1, 2021, and ending June 30, 2023.  
5       Section 54-44.1-11 does not apply to this funding, and any additional funds not spent by  
6       June 30, 2023, must be continued into the biennium beginning July 1, 2023, and ending  
7       June 30, 2025, and may be expended only for providing grants to airports.
