This bill removes the license and bonding requirements for a wool dealer.

This bill repeals Chapter 4.1-88 of the North Dakota Century Code relating to wool dealer licenses and bonds. The agriculture commissioner currently only licenses and bonds one wool dealer in North Dakota. The annual license fee is \$10.

Repealing Chapter 4.1-88 will result in a reduction of \$20 from the general fund per biennium.

The cost to license and bond one wool dealer is \$200 of salaries/benefits annually or \$400 per biennium.
