HB 1234 provides authorization of sports betting as a game of chance. This amendment provides regulation of sports wagering, provides for a legislative management study, and a contingent effective date.

There is no fiscal impact for the 2021-23 biennium. This bill has an effective date of August 1, 2023 if the House Concurrent Resolution 3032 is adopted and approved by the voters. The Attorney General Office estimates this bill will increase revenues and expenditures/appropriations but can not determine the financial impact of this bill for 2023-25 biennium.

There is no fiscal impact for the 2021-23 biennium. The Attorney General Office estimates this bill will increase revenues for the 2023-25 biennium however it unable to provide a reasonable estimate.

There is no fiscal impact for the 2021-23 biennium. For the 2023-25 biennium, this bill will generate a significant increase in workload. We anticipate adding a new division to handle internet gaming. This would include a new division director, administrative assistant, estimated 5 regulatory and/or audit staff, and operating. The operating would need to include a service provider and site operators. At this time, we don't have a good estimate on the total operating expenses needed.
