SB 2137 provides a sales and use tax exemption for enterprise information technology equipment and computer software used in a qualified data center.

Section 1 of the bill provides a sales and use tax exemption for the purchase of enterprise information technology equipment and computer software to be used by a qualifying data center. The bill limits the exemption to the first four facilities approved by the tax commissioner in each region and facilities with capital investments exceeding \$150 million.
