The House convened at 8:00 a.m., with Speaker K. Koppelman presiding.

The prayer was offered by Pastor Kai Hardee, Gateway Community Fellowship, Bismarck.

The roll was called and all members were present except Representatives Hoverson, M. Johnson, and Owens.

A quorum was declared by the Speaker.

**REMARKS OF REPRESENTATIVE KLEMIN**

Today is Veterans Day, the day set aside to honor all military veterans. It's a special day and was originally known as Armistice Day to remember the agreement made to end World War I on November 11, 1918, and the veterans who served in that war. The name of the day was changed to Veterans Day in 1954 to honor all veterans.

Today I would like to remember one particular veteran, Wesley N. Cook. Private Cook served in France in World War I in 1918 with a United States Army company of soldiers from Minnesota. He was in France on Armistice Day on November 11, 1918, when the war ended, 103 years ago.

His company was sent to France to serve as Rangers. They were not Rangers as we think of them today. Much of the war in France in 1918 was trench warfare. Our soldiers were in trenches facing enemy soldiers in trenches some distance away. Behind each of the trenches was artillery. In between the trenches was "no mans land". The mission of the Rangers in 1918 was to determine the range or distance to the enemy artillery. They calculated the range by the flash of the enemy artillery at night and by the sound of the artillery during the day. Their calculations were then given to our artillery so they could aim more accurately at the enemy artillery. They were also responsible for laying and repairing telephone lines that were used for communication.

The history of this company in France was written by a member of the company after the war in a book entitled "*Ranging in France with Flash and Sound*". Here is that book, copyright 1919. Private Cook is mentioned several times in this book.

In 1919, after the end of World War I, Private Cook and his company returned to the United States. I'm glad he made it back home, because Wesley N. Cook was my grandfather. Around 1925, Grandpa Cook and his young family moved to the New Rockford area where he was a farmer. He was a member of American Legion Post 30 in New Rockford. I am wearing his Legion cap today. I also have his dog tags with me.

Grandpa Cook passed away a long time ago. Today, on Veterans Day, I say: "Thank you for your service, Grandpa Cook!"

And thank you to all of the men and women who've served in the military forces of the United States of America! God bless you all!

**REMARKS OF REPRESENTATIVE TVEIT**

Early December 1967 my new bride of six months, Laurel, and I were getting ready to celebrate our first Christmas together. We were sitting and admiring our newly decorated tree in our home in Edgeley, North Dakota, opening Christmas cards together. One of the

first we opened was from Uncle Sam which simply said, "You have been selected - please report". And suddenly we had a career change facing us. My talk today reflects on the veterans on the home front, those we often overlook. These are veterans without ribbons or medals, many with scars, but no purple heart. These veterans come in many different groups - males, female, husbands, fathers, sons, wives, mothers, daughters, even grand children. Though there are many categories, for simplicity today, I will talk only of three such groups. In no way shape or form, do I wish to diminish the value and honor due the men and women we all recognize as veterans, those who served, as I expand the groups. However, I do wish, also to honor those who served right along side of the veterans we honor, prayed for them, encouraged them yet seldom are recognized for their time and sacrifices. To begin with let's look at the first veteran group. We all recognize and know someone in this category. There are those who serve in peace times, having never experienced a battle or war zone, yet their time in service is as important to us as those who have gone into the war zones and earned the medals. I cannot imagine our United States without a well trained, disciplined military ready at a moments notice to protect and defend this country, our heritage, and the rights of its citizens. Each and every one of these individuals are mission essential, willing to lay down their lives for their country. We need to honor them and thank them for their service. While you were off to college they were prepared to give their all in our defense. And then finally come home, after three or more years and then begin their careers. The next group of veterans also wore the uniform with pride. They too were mission essential. This is the group where I found myself. We served during a war time, yet once we completed our basic and advanced training we never heard the rattle of rapid fire, experienced a landmine explode, or had to take shelter during an air raid. We simply served, did our job to train, support, and supply those in the battle grounds or trenches so to speak. This group experienced few battles scars, received very few ribbons or medals, but served they did with honor. Our military would be useless and worthless without them. Much like you in this legislative session. Can you as speaker of the house, majority and minority leader, fellow legislators imagine getting through this session without our support staff - the custodians, pages, bill clerk, sergeant-at-arms, legislative council, etc.? The final veteran group I chose to call out and salute today with much gratitude is our home-front veteran. Also so mission essential. This is the group many unsung heroes, such as my mother, find themselves in holding down the home front with two small sons, anxiously waiting, receiving that dreaded telegram, a widow so young. Once again a veteran hero of fifty plus years, she lived with my father, a WWII combat veteran with post traumatic stress disorder. Once again, like so many mothers, Mom stood on the front porch with much anxiety and prayer as she watched two of her sons, a son-in-law, grandson, granddaughter, and grandson-in-law leave, some in peace time and some in time of war, to serve their country knowing full well the potential consequences. There are veterans like my wife, Laurel, who at 19 years of age watched, wondered, and prayed as she sent me off to basic training not knowing what our future would be while working out of the home, stretching our budget in any way she could to feed us because military pay was too little to exist on. Laurel, like many spouses, served with and along side me every day. I was young and for the first time ever away from home for three years in the United States Army. Though the army often said they did not issue me a wife, we were one before the army called me and I think she should stand and be honored as well anytime I as a veteran am asked to stand and be recognized. And then there are other true and tried veterans like my sister, Nancy Rader, of Cando, North Dakota who watched her husband and his National Guard unit leave for Iraq's Desert Storm. She was left on her own, with three little ones, to run the farm and also gave birth to their fourth child in his absence. Nancy is a veteran hero. In closing, it is not important where you served or when you served but what is important is that you were and are willing to do what you can, when you can, to serve your fellow countrymen and to support them in war or peace and preserve the America we all have grown to love. I would like anyone who served in the United States military during any war time to please stand and be recognized. Please remain standing. Now anyone who served in the military during peace time please stand and join them and remain standing. Now anyone who ever found themselves as a member of the home front in support of a veteran, also stand and be recognized. I wish for each of you a blessed and happy Veterans Day. Thank you for your service. Dwell on your blessings. Go in peace serving one another with joy and thanksgiving.

#### **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

**SECTION 1. AMENDMENT.** Section 21-10-11 of the North Dakota Century Code is amended and reenacted as follows:

**21-10-11. Legacy and budget stabilization fund advisory board.**

1. The legacy and budget stabilization fund advisory board is created to develop recommendations for the investment of funds in the legacy fund and the budget stabilization fund to present to the state investment board.
2. The goal of investment for the legacy fund is principal preservation while maximizing total return and to provide a direct benefit to the state by investing a portion of the principal in the state. Preference must be given to qualified investment firms and financial institutions with a presence in the state for investment of the legacy fund.
3. The board shall determine the asset allocation for the investment of the principal of the legacy fund including:
  - a. A target allocation of ten percent to fixed income investments within the state, of which:
    - (1) Up to forty percent must be targeted for infrastructure loans to political subdivisions under section 6-09-49.1. The net return to the legacy fund under this paragraph must be fixed at a target rate of one and one-half percent;
    - (2) Up to sixty percent, with a minimum of four hundred million dollars, must be designated to the Bank of North Dakota's certificate of deposit match program with an interest rate fixed at the equivalent yield of United States treasury bonds having the same term, up to a maximum term of twenty years; and
    - (3) Any remaining amounts must be designated for other qualified fixed income investments within the state.
  - b. A target allocation of ten percent to equity investments in the state, of which at:
    - (1) At least three percent may be targeted for investment in one or more equity funds, venture capital funds, or alternative investment funds with a primary strategy of investing in emerging or expanding companies in the state. Equity investments under this subdivision paragraph must:
      - ~~(1)(a)~~ Be managed by qualified investment firms, financial institutions, or equity funds which have a strategy to invest in qualified companies operating or seeking to operate in the state and which have a direct connection to the state; and
      - ~~(2)(b)~~ Have a benchmark investment return equal to the five-year average net return for the legacy fund, excluding in-state investments.
    - (2) The legacy and budget stabilization fund advisory board shall develop guidelines for eligible investments under this paragraph. The advisory board shall receive and review proposals for eligible investments under this paragraph, and the advisory board shall consult with industry representatives, financial professionals, or other technical advisors to review the proposed investments. The advisory board shall submit recommendations for investments under this paragraph to the state investment board.
4. The board consists of ~~two~~three members of the senate appointed by the senate majority leader, ~~two~~three members of the house of representatives appointed by the house majority leader, ~~the director of~~

~~the office of management and budget or designee, the president of the Bank of North Dakota or designee, and the tax commissioner or designee, the insurance commissioner or designee, and the state treasurer or designee.~~ The board shall select a member from the senate or house of representatives to serve as chairman for no more than one consecutive year and must meet at the call of the chairman.

5. The board shall report at least semiannually to the budget section.
6. Legislative members are entitled to receive compensation and expense reimbursement as provided under section 54-03-20 and reimbursement for mileage as provided by law for state officers. The legislative council shall pay the compensation and expense reimbursement for the legislative members.
7. The legislative council shall provide staff services to the legacy and budget stabilization fund advisory board.
8. The staff and consultants of the state retirement and investment office shall advise the board in developing asset allocation and investment policies.
9. The board ~~shall~~may develop a process to select a member of the board who is not a member of the state investment board to serve on the state investment board in a nonvoting capacity.

**SECTION 2. LEGACY AND BUDGET STABILIZATION FUND ADVISORY BOARD - SELECTION OF CHAIRMAN.** Pursuant to the requirement for the legacy and budget stabilization fund advisory board to select a chairman under subsection 4 of section 21-10-11, the advisory board shall select a new chairman during its first meeting after the effective date of this Act.

**SECTION 3. EFFECTIVE DATE.** This Act becomes effective on December 1, 2021."

#### **CORRECTION AND REVISION OF THE JOURNAL**

**MR. SPEAKER:** Your **Committee on Correction and Revision of the Journal (Rep. Bellew, Chairman)** has carefully examined the Journal of the Third Day and recommends that it be corrected as follows and when so corrected, recommends that it be approved:

Page 2243, replace line 28 with:

**"DIVISION A:** Those parts of Section 1 stated as follows:

Districts 4 and 9 are divided into subdistricts, and one representative must be elected from each subdistrict. A representative elected from a subdistrict must be, on the day of election, a qualified elector in the subdistrict from which the representative was chosen.

Before approving any request, the budget section shall determine:

1. Approving additional appropriations will not negatively affect the sixty-seventh legislative assembly's ability to address water-related needs;
2. The proposed use of the additional income complies with legislative intent; and
3. The proposed use of the additional income will not result in future funding commitments.

**SECTION 7. WATER PROJECTS STABILIZATION FUND - TRANSFERS.**

1. The office of management and budget shall transfer the sum of \$1,000,000 from the resources trust fund to the water projects stabilization fund during the month of January 2022.
2. Notwithstanding subsections 1 and 2 of section 57-51.1-07, any oil extraction tax revenues deposited in the resources trust fund that exceed the amount included in the 2021 legislative forecast during the period beginning August 1, 2021, and ending February 28, 2023, must be

transferred at least quarterly by the office of management and budget from the resources trust fund to the water projects stabilization fund for the period beginning with the effective date of this Act, and ending June 30, 2023."

#### Limitations on disciplinary actions.

The board may not take disciplinary action against an advanced practice registered nurse based solely on the advanced practice registered nurse prescribing or dispensing ivermectin for the off-label treatment or prevention of severe acute respiratory syndrome coronavirus 2 identified as SARS-CoV-2, or any mutation or viral fragments of SARS-CoV-2. This section does not limit the board from taking a disciplinary action on another basis, such as unlicensed practice, inappropriate documentation, or substandard care, or any basis that would in the board's determination harm the patient.

**SECTION 2.** A new section to chapter 43-15 of the North Dakota Century Code is created and enacted as follows:

**Limitations on disciplinary actions.**

The board may not take disciplinary action against a pharmacist based solely on the pharmacist dispensing ivermectin for the off-label treatment or prevention of severe acute respiratory syndrome coronavirus 2 identified as SARS-CoV-2, or any mutation or viral fragments of SARS-CoV-2. This section does not limit the board from taking a disciplinary action on another basis, such as unlicensed practice, inappropriate documentation, or substandard care, or any basis that would in the board's determination harm the patient.

**SECTION 3.** A new section to chapter 43-17 of the North Dakota Century Code is created and enacted as follows:

**Limitations on disciplinary actions.**

The board may not take disciplinary action against a licensee based solely on the licensee prescribing or dispensing ivermectin for the off-label treatment or prevention of severe acute respiratory syndrome coronavirus 2 identified as SARS-CoV-2, or any mutation or viral fragments of SARS-CoV-2. This section does not limit the board from taking a disciplinary action on another basis, such as unlicensed practice, inappropriate documentation, or substandard care, or any basis that would in the board's determination harm the patient.

**SECTION 4. EFFECTIVE DATE.** This Act becomes effective upon its filing with the secretary of state."

Notwithstanding any other provision of law, a health care provider, elementary or secondary school, early childhood facility, public or private postsecondary educational institution, city or county board of health, district health unit, and the state health officer may exchange immunization data in any manner with one another. Immunization data that may be exchanged under this section is limited to the date and type of immunization administered to a patient and may be exchanged regardless of the date of the immunization.
4. The state department of health may not create, administer, provide, or contract for an immunization certificate, such as a vaccine passport or an electronic machine-readable code.

**Immunization data. (Effective after August 31, 2022)**

1.
