| Transfer - General Fund - Bioscience innovation grant fund - Bioscience innovation grant program | Section 3 requires the Office of Management and Budget to transfer \$5.5 million from the general fund to the bioscience innovation grant fund for the purpose of providing bioscience innovation grants during the 2021-23 biennium. |
| Transfer - General Fund - Federal environmental law impact review fund | Section 4 requires the Office of Management and Budget to transfer \$5 million from the general fund to the federal environmental law impact review fund for the purpose of defraying costs associated with federal environmental legislation or regulations which detrimentally impact or potentially detrimentally impact the state's agricultural, energy, or oil production sectors during the 2021-23 biennium. |
| Transfer - Bank of North Dakota profits - Outdoor heritage fund - Soil health cover crop cost share program - One-time funding | Section 5 identifies funding of \$500,000 in the estimated income line item in Section 1 is for a soil health cover crop cost share program, of which \$300,000 is from the current earnings and undivided profits of the Bank of North Dakota, from which the Industrial Commission shall transfer to the Agriculture Commissioner for deposit in the agriculture department operating fund during the 2021-23 biennium, and \$200,000 is from the outdoor heritage fund. The funding is considered a one-time funding item. |
| Transfer - Bank of North Dakota profits - Agricultural Products Utilization Commission - One-time funding | Section 6 identifies funding of \$2.7 million in the estimated income line item in Section 1 is from the Agricultural Products Utilization Commission fund. The Industrial Commission is required to transfer \$2.7 million from the current earnings and undivided profits of the Bank of North Dakota to the Agriculture Commissioner for deposit in the Agricultural Products Utilization Commission fund during the 2021-23 biennium. The funding is considered a one-time funding item. |
| Transfer - State Water Commission | Section 7 transfers \$125,000 from the State Water Commission to the Agriculture Commissioner for the Wildlife Services program during the 2021-23 biennium. |
| Transfer - Environment and rangeland protection fund | Section 8 requires the Agriculture Commissioner to transfer \$325,000 from the environment and rangeland protection fund to the minor use pesticide fund during the 2021-23 biennium. |

Environment and rangeland protection fund	Section 9 identifies \$6,896,664 in the estimated income line item in Section 1 is from the environment and rangeland protection fund.
Game and Fish Department operating fund	Section 10 identifies \$614,430 in the estimated income line item in Section 1 is from the Game and Fish Department operating fund for various Department of Agriculture programs.
Additional federal funds spending authority - One-time funding	Section 11 identifies \$20,000,000 in the estimated income line item in Section 1 is from additional federal funds that become available to the Agriculture Commissioner during the 2021-23 biennium. It is the intent of the 67th Legislative Assembly that this funding be used for the Agriculture Commissioner's meat processor cost-share program. The Agriculture Commissioner is required to report periodically to the Budget Section during the 2021-22 interim regarding any federal funds received and spent pursuant to this section. The funding is considered a one-time funding item.
North Dakota Trade Office - Matching Fund Requirement	Section 12 identifies \$1,600,000 in the North Dakota trade office line item relates to the North Dakota Trade Office. The Agriculture Commissioner may spend 60 percent of this amount without requiring any matching funds from the North Dakota Trade Office. Any additional amounts may be spent only to the extent the North Dakota Trade Office provides \$1 of matching funds from private or other sources for each \$1 provided by the Agriculture Commissioner during the 2021-23 biennium. Matching funds may include money spent by businesses or organizations to pay salaries to export assistants, to provide training, and to buy computer equipment as part of the North Dakota Trade Office's export assistant program.
Agriculture Commissioner salary	Section 13 provides the statutory changes necessary to increase the Agriculture Commissioner's salary. The Agriculture Commissioner's annual salary would increase from the current level of \$119,757 to \$122,152 effective July 1, 2021, and to \$124,595 effective July 1, 2022, to reflect annual increases of 2 percent each year.

Pipeline restoration and reclamation - Exempt records

Section 14 amends Section 4.1-01-17 to exempt the names of surface owners and surface tenants who receive assistance from the pipeline restoration and reclamation program from open records request laws.

Pipeline restoration and reclamation - Estimated income

Section 15 identifies \$200,000 in the estimated income line item in Section 1 is from the abandoned oil and gas well plugging and site reclamation fund for the pipeline restoration and reclamation program.

Waterbank program - 2019-21 biennium

Section 16 amends Section 7 of Chapter 34 of the 2019 Session Laws to allow the Agriculture Commissioner to use "up to" \$50,000 of the 2019-21 biennium salaries and wages line item as matching funds for the North Dakota outdoor heritage fund grant for the waterbank program.

Waterbank program - 2021-23 biennium

Section 17 identifies of the amount appropriated in the salary and wages line item in Section 1, the Agriculture Commissioner may use up to \$50,000 from the general fund for matching funds for the North Dakota outdoor heritage fund grant provided for the waterbank program.
