HB 1420 - Adult Use Cannabis Senate Human Services - Judy Lee, Chair

I'm Jonah Lantto, a Minot business owner.

The results of prohibition are a failure. Our current position regarding marijuana is a detriment to North Dakota prosperity, opportunity, and gainful citizenship. There is no evidence prohibition has benefited the people of North Dakota. There is however, plenty of evidence to show prohibition has stood in the way of success. It has created criminals out of otherwise good people. I ask this chamber: Would you call the cops on your kids or grandchildren if you discovered them with marijuana?
