## PROPOSED AMENDMENTS TO SENATE BILL NO. 2068

Page 1, line 1, after "enact" insert "a new section to chapter 16.1-01 and"

Page 1, line 2, after "official" insert "; to amend and reenact subsections 2 and 4 of section 16.1-01-09.1 of the North Dakota Century Code, relating to the recall of an elected official of a political subdivision; and to provide for a legislative management study"

Page 1, after line 3, insert:

"SECTION 1. A new section to chapter 16.1-01 of the North Dakota Century Code is created and enacted as follows:

## Recall - Responsibility for costs.

Up to twenty-five thousand dollars of any costs associated with the recall of an elected official, or an appointed official of a vacated elected office, of a legislative district, county, or other political subdivision must be paid by the legislative district, county, or political subdivision in which the individual being recalled is an elected or appointed official.

SECTION 2. AMENDMENT. Subsections 2 and 4 of section 16.1-01-09.1 of the North Dakota Century Code are amended and reenacted as follows:

An individual may not sign a recall petition circulated pursuant to article III of the Constitution of North Dakota or section 44-08-21 unless the individual is a qualified elector. An individual may not sign a petition more than once, and each signer shall also legibly print the signer's name, complete residential, rural route, or general delivery address, and the date of signing on the petition. Every qualified elector signing a petition must do so in the presence of the individual circulating the petition. A petition must be in substantially the following form:

During the 2021-22 interim, the legislative management shall consider studying how the passage of sections 1, 2, and 3 of this Act regarding the responsibility for the costs associated with a recall of an elected official or an appointed official of a vacated elected office impacts political subdivisions. The legislative management shall report its findings and recommendations, together with any legislation required to implement the recommendations to the sixty-eighth legislative assembly."
